

ORDINANCE NO. 2199

**AN ORDINANCE OF THE CITY OF ALICE, TEXAS; UPDATING
APPENDIX C: FEE SCHEDULE OF THE CITY OF ALICE TO
THE CODE OF ORDINANCES; MAKING FINDINGS OF FACT;
PROVIDING FOR SEVERABILITY; AND PROVIDING
EFFECTIVE DATE AND OPEN MEETINGS CLAUSES.**

WHEREAS, the City Council of the City of Alice has previously adopted fees for various services and facilities;

WHEREAS, APPENDIX C: FEE SCHEDULE of the City of Alice Code of Ordinances is hereby updated and includes changes made since the last codification of the Code of Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALICE, TEXAS, THAT:

Section 1. Findings of Fact. The above and foregoing recitals are hereby found to be true and correct and are incorporated herein as findings of fact.

Section 2. Appendix C: Fee Schedule Adopted. The City Council hereby adopts Appendix C: Fee Schedule to read as set forth in the attachment hereto entitled "**Appendix C: Fee Schedule**", attached to and incorporated in this ordinance as though fully transcribed herein for all purposes.

Section 3. Amendment of Ordinances. **Appendix C** of the Alice Code of Ordinances is hereby added in its entirety and all ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance as adopted, are hereby amended to the extent of such conflict. In the event of a conflict or inconsistency between this ordinance and any other code or ordinance of the City, the terms and provisions of this ordinance shall govern.

Section 4. Savings Clause. All rights and remedies of the City of Alice are expressly saved as to any and all violations of the provisions of any ordinances affecting fees within the City which have accrued at the time of the effective date of this ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances, same shall not be affected by this ordinance but may be prosecuted until final disposition by the courts.

Section 5. Effective Date. This ordinance shall take effect immediately from and after its passage in accordance with the provisions of the Texas Local Government Code.


Section 6. Severability. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable and, if any phrase, sentence, paragraph or section of this Ordinance should be

declared invalid by the final judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation of this ordinance of any such invalid phrase, clause, sentence, paragraph or section. If any provision of this Ordinance shall be adjudged by a court of competent jurisdiction to be invalid, the invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provision, and to this end the provisions of this Ordinance are declared to be severable.


Section 7. Open Meetings. It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place and purpose of said meeting was given as required by the Texas Open Meetings Act.

Industrial Waste (Ord. 1341-1286 Sec. 22-157)

(a) Charge determination; routine sampling and testing:

If the volume or character of the waste to be accepted by the city is such that it will not overload the sewage collection, pumping, handling, treating, or disposal facilities of the city, then prior to such acceptance, the city and the industrial concern shall enter into an agreement whereby the industrial concern shall make payment of an industrial waste charge to be determined as set forth below:

The Industrial charge shall be calculated by the following:

The determination of flow, B.O.D., and suspended materials shall be made by the city laboratory and if the firm or industry concerned shall send samples to an independent laboratory, then the cost of the sample shall be paid solely by the firm or industry. The time of selection of the sample shall be at the sole discretion of the city, but at least on an annual basis to adjust the industrial charge to reflect the current costs of wastewater treatment. The applicable surcharge determined by such tests shall be retroactive for two (2) billing periods and shall continue for six (6) billing periods unless subsequent tests determine that the surcharge should be further increased.

(b) Surcharge for exceeding limits; routine re-testing:

Before establishing a surcharge, the owner must be notified in writing that the waste discharge from his property exceeds the maximum limits as established in this division. If after three (3) consecutive monthly inspections, the quality has not been brought within the maximum allowed, the customer must enter into a surcharge agreement or be disconnected from the city's sanitary sewer system. Thereafter the flow will be routinely inspected each six (6) months and if found above or below the maximum allowed, the surcharge will be adjusted accordingly.

Computations of each surcharge, as applicable, shall be based on the following:

$$S = V \times 8.34 \times .075 \times (\text{B.O.D.} - 200); \text{ and}$$

$$S = V \times 8.34 \times .075 \times (\text{S.S.} - 200).$$

Private Fire Protection Water Rate (Ord. of 6/23/75 Sec. 22-58)

Private fire protection water rates for nonmetered service by the city shall be the net annual charge for water service made available when such charges are paid in advance or before January 31 of each year such service is to be rendered.

Otherwise such charges shall be subject to a penalty of increased charges in the amount of ten (10) percent of the net charges if payment is made on or before March 1 of the current year. Should payment of charges not be made on or before March 1 of the current year, water service shall be discontinued. If paid after March 1 a turn-on fee of three dollars (\$3.00) shall be made.

(1) Type Nos. 1 & 2 (nonmetered)

(2) Type No. 2.
