AN ORDINANCE OF THE VILLAGE OF CLAYCOMO, CLAY COUNTY, MISSOURI, AMENDING CHAPTER 11 OF THE CODE OF ORDINANCES, BY AMENDING SECTIONS 11-25 COURT COSTS

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF CLAYCOMO AS FOLLOWS:

SECTION 1. That the Code of Ordinances of the Village of Claycomo, Chapter 11: Municipal Court; Section 11.25: Court Costs be amended as outlined below:

Section 11.11-25. Court Costs

So long as Village court cases are heard by the Village Municipal Judge, in addition to any fine that may be imposed by the Judge in any case filed in the Village of Claycomo, and in addition to all other fees authorized or required by law, there shall be assess as costs on each case the following:

- A. Costs for the court shall be eleven dollars (\$11.00) per case which costs shall be collected according to RSMo Section 479.260 and shall be transmitted monthly to the Treasurer of the Village plus the following surcharges:
 - a. Three dollars (\$3.00) for law enforcement training fund surcharge. Two dollars (\$2.00) of this three dollars (\$3.00) shall be collected according to RSMo 590.140 by the Municipal Court Clerk and shall be transmitted monthly to the peace officer standards and training commission fund (made payable to the Treasurer, State of Missouri) to be used statewide for training law enforcement officers.
 - b. One dollar (\$1.00) for shelter house fees. One dollar (\$1.00) shall be collected according to RSMo 479.261 by the Municipal Court Clerk and shall be transmitted monthly to the designated shelter for battered persons, Synergy Services, Inc.
 - c. Seven dollars and fifty cents (\$7.50) for the crime victim's compensation fund. Seven dollars and thirteen cents (\$7.13) shall be collected according to RSMo 595.045 by the Municipal Court Clerk and shall be transmitted monthly to the Director of Revenue, State of Missouri. The remaining thirty-seven cents (\$0.37) shall be retained by the Village.
 - d. One dollar (\$1.00) for judicial training fund. One dollar (\$1.00) shall be collected as allowed by RSMo 479.260 by the Municipal Court Clerk and shall be transmitted monthly to the Treasurer of the Village, to be used locally for training of municipal court personnel.
 - e. Two dollars (\$2.00) shall be assessed for the Inmate Prisoner Detainee Security Fund established and authorized by the State Statute 488.5026.1, RSMo., except in any proceeding when the proceeding or the defendant has been dismissed by the Court. Such fee shall be collected by the Clerk of the Court and shall be disbursed as provided in Sections 488.010 to 488.020, RSMo. The Village Treasurer shall deposit funds generated by the surcharge into the above referenced fund. The funds generated by such fee shall be used for such purposes as set forth in paragraph 488.5026.1, Subsection 3, RSMo., specifically to acquire and develop biometric verification systems and information sharing to ensure that inmates, prisoner, or detainees in a holding cell facility or other detention facility or area which hold persons detained only for a shorter period of time after arrest or

after being formally charged can be properly identified upon booking and tracked with the local law enforcement administration system, Criminal Justice administration System, or the local jail system. Upon the installation of the information sharing or biometric verification system, funds in the inmate prisoner detainee security fund may also be used for maintenance, repair and replacement of the information sharing or biometric verification system, and to pay for any expenses related to the detention, custody and housing and other expenses for inmates, prisoners, and detainees.

- f. Mileage, in the same amount as provided to the Sheriff in criminal violations, for each mile and fraction thereof the officer must travel (both directions) to serve any warrant or commitment or order of this court.
- g. One dollar (\$1.00) shall be collected according to RSMo 302.127 by the Municipal Court and is only assessed on all cases where the operator of any motor vehicle, motorcycle, or motor tricycle, violates a municipal ordinance where violation involves motorcycle or motor tricycle and causes an accident. These court costs shall be doubled if the operator at fault violated any state law or local ordinance relating to the consumption of alcohol.
- h. The DWI/Drug Enforcement Fund will be collected according to the Village of Claycomo Code of Ordinances, Ordinance No. 27-91 by the Municipal Court Clerk and is only assessed upon a plea of guilty, finding of guilt or conviction for violation of provisions of Sections 27-70 and 27-71 (alcohol or drug-related traffic offense), the court may, in addition to imposition of any penalties provided by law, order the person to reimburse law enforcement authorities for costs associated with such arrest and shall be transmitted monthly to the Treasurer of the Village.

This ordinance shall be in full force and effect from and after its passage and approval by the Chairman and Board of Trustees of the Village of Claycomo.
