

**ORDINANCE NO. 4605-24**

**AN ORDINANCE AMENDING CHAPTER 6, SECTION 6-49. – REVOCATION  
AUTHORIZED, OF THE CODE OF ORDINANCES OF THE CITY OF LOVES PARK,  
ILLINOIS.**

WHEREAS, Chapter 6 of the Code of Ordinances (“Code”) for the City of Loves Park (“City”) regulates alcoholic beverages being sold and served within the City; and

WHEREAS, Chapter 6, Section 6-49 – Revocation authorized., establishes that the mayor may revoke, suspend, or fine any retail liquor dealer’s license for any violation of Chapter 6 of the Code or any state law pertaining to the sale of alcoholic liquor; and

WHEREAS, the City desires to amend Chapter 6, Section 6-49. – Revocation authorized., establishing a time frame of when a liquor license may be applied for at a location where a revocation has taken place;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVES PARK, WINNEBAGO COUNTY, ILLINOIS AS FOLLOWS:


**Chapter 6, Section 6-49 – Revocation authorized.**

The mayor may revoke, suspend or fine any retail liquor dealer’s license for any violation of any provision of this chapter, or for any violation of any state law pertaining to the sale of alcoholic liquor. No liquor license will be advanced for consideration for a location where a revocation has taken place within 30 days or, if applicable, while the revocation of said liquor license is pending appeal.


