ORDINANCE 2017-07

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MINNEOLA, FLORIDA, ESTABLISHING MONTHLY SOLID WASTE COLLECTION FEES PURSUANT TO THE NEW FRANCHISE AGREEMENT; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Minneola voted to award the Franchise Agreement for Solid Waste Collection(the "Agreement") to WCA of Florida, LLC, dated March 28, 2017, and effective May 1, 2017; and

WHEREAS, the Agreement provides for a fixed rate over the entire term of the Agreement; and

WHEREAS, Article XI, Section 11.5(e) of the Charter of the City of Minneola provides that an ordinance is required for any act of this City which sets service or user charges for municipal services or granting administrative authority for such charges; and

WHEREAS, the City Council of the City of Minneola desires to amend Section 58-1¹7(1) of the city code to comply with the bargained-for collection fee provided in the Agreement.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MINNEOLA AS FOLLOWS:

- Section 1. The solid waste collection fee for single-family residential properties within the city shall be \$23 41
- <u>Section 2.</u> The collection fee for twice a week single cart hand collection for commercial establishments within the city shall be \$49.50
- Section 3. The collection fee matrix for commercial collection by cubic yard shall be as reflected in the attached Exhibit "A." All other rates as set forth in the Agreement are hereby approved.
 - **Section 4.** These rates shall be effective retroactively to May 1, 2017.
- <u>Section 5.</u> If any section or portion of a section of this Ordinance proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Ordinance.
- <u>Section 6.</u> All ordinances or parts of ordinances in conflict here with are hereby repealed.

Section 7. This Ordinance shall become effective immediately upon passage.
