

**ORDINANCE NO. 1360**

**AN ORDINANCE AMENDING CHAPTER 25 MUNICIPAL, FEES AND CHARGES, SECTION 25.13, ENTITLED "SOLID WASTE CHARGES" OF THE MOUNT PLEASANT MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOUNT PLEASANT,**

**IOWA:**

Section 1.

**AMENDMENT 1** Section 25.13(c)(1) of the Mount Pleasant Municipal Code is hereby amended to change the base fee from Two Dollars and Fifty cents (\$2.50) to Three Dollars. Section 25.13(c)(1) shall provide as follows:

**Each residential dwelling unit shall be billed a collection charge of three dollars (3.00) per month, regardless of its participation or lack of participation in the city garbage pickup services.**

**AMENDMENT 2** Section 25.13(c)(2) of the Mount Pleasant Municipal Code is hereby amended to change the base fee from Two Dollars and Fifty cents (\$2.50) to Three Dollars (\$3.00).

**Each apartment unit or mobile home shall be billed a collection charge of three dollars (\$3.00) per month, regardless of its participation or lack of participation in the city garbage pickup services. For those units or mobile homes that are on a shared meter system, the owner shall be billed the sum of three dollars (\$3.00) per month multiplied by the number of units or mobile homes.**

**AMENDMENT 3** Section 25.13(cX3) of the Mount Pleasant Municipal Code is hereby amended to change the base fee from Two Dollars and Seventy-five cents (\$2.75) to Three Dollars (\$3.00).

**Each commercial or business facility shall be billed a collection charge of three dollars (\$3.00) per month, regardless of its participation or lack of participation in the city garbage pickup services. For those businesses that are on a shared meter system, the owner shall be billed the sum of three dollars (\$3.00) per month multiplied by the number of commercial or business units.**

**AMENDMENT 4** Section 25.13(c)(4) of the Mount Pleasant Municipal Code is hereby amended to change the recycling fee from Three Dollars and Seventy-five cents (\$3.75) to Three Dollars and Eighty-five cents (\$3.85).

**Each residential dwelling unit, apartment unit, and mobile home, shall be billed the amount of three dollars and Eighty-five cents (\$3.85) per month, such sum representing a recycling fee that has not otherwise been included in the garbage pickup services.**

Section 2. **REPEALER.** All Ordinances or parts of Ordinances in conflict with the provisions of

this Ordinance are hereby repealed.

Section 3. **SEVERABILITY CLAUSE.** If any section, provision or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. **EFFECTIVE DATE.** This Ordinance shall be in effect July 1, 2019 after its final passage, approval and publication as provided by law.
