1 **RESOLUTION NO. 2023-09** 2 3 A RESOLUTION OF THE TOWN OF PONCE INLET. 4 FLORIDA AUTHORIZING THE OFFICIAL LOGO OF THE 5 TOWN OF PONCE INLET TO BE USED ON THE 6 CITIZENS FOR PONCE INLET (C4PI) NEWSLETTER; 7 PROVIDING FOR CONFILICTING RESOLUTIONS: 8 PROVIDING FOR SEVERABILITY; AND PROVIDING 9 FOR AN EFFECTIVE DATE. 10 11 WHEREAS, the Town Council of the Town of Ponce believes it is in the best interest of 12 the Town to continue to keep the citizens and businesses within the Town informed of what is 13 occurring in the Town government and, periodically, to provide information regarding other 14 governmental entities serving the citizens of Ponce Inlet when such information would be helpful; 15 and 16 17 WHEREAS, the Town of Ponce Inlet has utilized the Citizens for Ponce Inlet Newsletter, 18 published by the Citizens for Ponce Inlet (C4PI), a private organization, to publish information 19 about the workings of Town and other government; and 20 21 WHEREAS, but for the Citizens for Ponce Inlet Newsletter, the Town would publish its 22 own newsletter, and, therefore, the Town contributes funds to the C4PI for website fees to ensure 23 that information is available online at no additional cost to Ponce Inlet residents, subject to annual 24 appropriation; and 25 26 WHEREAS, the Town Council is appreciative of the important service which the C4PI 27 provides by making its Newsletter available for publication of Town government news; and 28 29 WHEREAS, beginning with its February 2010 issue, C4PI has included the Town of Ponce Inlet Logo on the cover of its newsletters; and 30 31 32 WHEREAS, on March 21, 2013, the Town Council adopted Ordinance 2013-03, 33 establishing the official Town Seal and Town Logo, and limiting its use only by authorized agents, employees, or officers of the Town of Ponce Inlet in conducting official business of the Town, and 34 35 further prohibiting its use by other persons without the express written approval of the Town 36 Council, pursuant to Section 165.043, Florida Statutes; and 37 38 WHEREAS, in furtherance of its goal of providing information in the Newsletter to its 39 citizens and businesses of the workings of the Town government, the Town desires to authorize 40 C4PI to continue using the Town Logo on its newsletters. 41 42

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF PONCE INLET, FLORIDA AS FOLLOWS:
