Alderman Kaplan

presents the following ordinance:

Amending Title 20, Chap 536 of the Minneapolis Code of Ordinances relating to Zoning Code: Zoning Districts and Maps Generally.

The City Council of the City of Minneapolis do ordain as follows:

Section 1. That Section 536.20 of the above entitled ordinance be amended by changing the zoning district for the following parcels of land, pursuant to MS 462.357:

A. All of Lot 3, Auditor's Subd of Blk 30, Murphy's Addn to Minneapolis;

B. All those parts of Lots 1, 2, 8 & 4, Auditor's Subd of Blk 30, Murphy's Addn to Minneapolis described as follows:

That part of Lot 1 of said addn lying SEly of the following described line: Commencing at a point on the N line of Lot 1 which is 57' W of the NE corner of said Lot 1; thence SWly to a point on the S line of said Lot 1 which point is distant 100' W of the SE corner of said Lot 1 and there terminating;

C. Those parts of Lots 2, 8 & 4 lying SEly of the following described line:

Commencing at a point on the S line of Lot 1 of said Addn, which point is distant 100' W of the SE corner of said Lot 1; thence SWly to a point described as follows: Commencing at a point on the S line of said Lot 8, distant 11' E of its intersection with the NEly line of Minnehaha Av: thence continuing SWly along the last described line to a point where it intersects

the NEly line of Minnehaha Av as now laid out and there terminating; all according to the recorded plat thereof on file and of record in the office of the Register of Deeds, in and for Hennepin Co, Minn (900-920 - 20th Av S - Plate 21) to the R6 District.
