Amending Title 14, Chapter 363 of the Minneapolis Code of Ordinances relating to Liquor and Beer: Wine Licenses.

The City Council of the City of Minneapolis do ordain as follows:

Section 1. That Subsection 363.40(e) of the Minneapolis Code of Ordinances be amended to read as follows:

(e) Class D. A Class D "on sale" wine license shall permit all Class E activities, and in addition thereto shall permit nonamplified music by one musician, and group singing participated in by patrons of the establishment.

AND ETHNIC DANCE, PROVIDED THAT SUCH DANCE SHALL BE PERFORMED ONLY IN CONJUNCTION WITH FULL SERVICE RESTAURANT DINING FOR PATRONS SEATED AT TABLES. ETHNIC DANCE SHALL MEAN A TRADITIONAL AND AUTHENTIC DANCE PERFORMANCE NATIVE TO AN ETHNIC CULTURAL GROUP, PERFORMED BY DANCERS ATTIRED WITH FULLY OPAQUE COVERING OVER GENITALS, PUBIC AREA, BUTTOCKS, AND FEMALE BREASTS BELOW THE TOP OF THE AREOLA. THE MAXIMUM NUMBER OF ETHNIC DANCERS SHALL BE THE SAME AS THE MAXIMUM NUMBER OF MUSICIANS PERMITTED BY EACH LICENSE CLASS. ■
