## 89-0r-173 AN ORDINANCE of the CITY OF MINNEAPOLIS

Council Member Niemiec

\_\_\_\_ presents the following ordinance:

Amending Title 10, Chapter 188 of the Minneapolis Code of Ordinances relating to Food And Food Handlers: Establishments Generally.

The City Council of the City of Minneapolis do ordain as follows:

Section 1. That Section 188.10 of the Minneapolis Code of Ordinances is amended by changing the definition of "Itinerant Food Establishment" to read as follows, and by placing the new definition in proper alphabetical order:

Itinerant SHORT TERM food establishment is a food establishment operating for a period of fourteen (14) days or less at fairs, community celebrations, carnivals, circuses and the like.

Section 2. That Section 188.10 of the Minneapolis Code of Ordinances be amended by adding thereto a new definition of Seasonal Short Term Food Establishment to read as follows, and by placing the definition in proper alphabetical order:

Seasonal Short Term Food Establishment is a person who pays an annual fee to operate at multiple, approved short term food events, such as fairs, carnivals, and community celebrations, and is an approved participant under the auspices and control of each such event.

Section 3. That Section 188.110 of the above-entitled orginance be amended to read as follows:

188.110. Short-term permits. Permits for the sale of food and drink for a period of less than fourteen (14) days at community celebrations, circuses, and other like and similar occasions, may be issued upon proper application and the payment of a fifty dollar (\$50.00) fee. A SEASONAL SHORT TERM FOOD ESTABLISHMENT LICENSE MAY BE ISSUED UPON PROPER APPLICATION AND PAYMENT OF A ONE HUNDRED FIFTY DOLLAR (\$150.00) FEE. The operation of itinerant SHORT TERM food establishments AND SEASONAL SHORT TERM FOOD ESTABLISHMENTS must be in conformity with the provisions of this chapter.

Section 4. That Section 188.190 of the Minneapolis Code of Ordinances be amended by adding, between "sidewalk cart food vendor" fees and "food shelf" fees, the following new license fee:

FOR SEASONAL SHORT TERM FOOD ESTABLISHMENT......\$150.00.
