Amending Title 18, Chapter 478 of the Minneapolis Code of Ordinances relating to Traffic Code: Parking, Stopping and Standing.

The City Council of The City of Minneapolis do ordain as follows:

Section 1. That Section 478.590 of the above-entitled ordinance be amended by adding thereto the following No Parking Zones:

No. 6124 - Ely side of 3rd Av S beginning at Nly curb line of S 3rd St & thence extending 137' Nly (No Parking, Bus Stop Zone).

No. 6125 - Ely side of 3rd Av S beginning 98' Nly from Nly curb line of S 4th St & thence extending 87' Nly (No Parking, Bus Stop Zone).

No. 6126 - Ely side of 3rd Av S beginning at Nly curb line of S 7th St & thence extending 157' Nly (No Parking, Bus Stop Zone).

No. 6127 - Wly side of 3rd Av S beginning 114' Sly of Sly curb line of Washington Av S & thence extending 80' Sly (No Parking, Bus Stop Zone).

No. 6128 - Wly side of 3rd Av S beginning 107' Sly of Sly curb line of S 5th St & thence extending 112' Sly (No Parking, Bus Stop Zone).

No. 6129 - Wly side of 3rd Av S betw limits of 3rd & 4th Sts S (No Parking, 7-9AM, 4-6PM, Mon-Fri).

No. 6130 - Wly side of 3rd Av S betw limits of 7th & 8th Sts S (No Parking, 7-9AM, 4-6PM, Mon-Fri).

No. 6131 - Wly side of 3rd Av S betw limits of 10th & 11th Sts S (No Parking, 7-9AM, 4-6PM, Mon-Fri).
