presents the following ordinance:

Amending Title 18, Chapter 478 of the Minneapolis Code of Ordinances relating to Traffic Code: Parking, Stopping and Standing.

Section 1. That Sec. 478.560 of the above-entitled ordinance be amended by adding thereto the following Handicap Transfer Zones:

- No. 681 - Ely side of Queen Av N beg 373' Nly of the Nly curb line of 34th Av N & th extending 40' Nly (No Parking, Handicap Parking Zone);
- No. 682 - Wly side of 13th Av S beg 272' Sly of the Sly curb line of E 24th St & th extending 30' Sly (No Parking, Handicap Parking Zone);
- No. 683 - Ely side of Aldrich Av S beg 15' Nly of the Nly curb line of W 50th St & th extending 40' Nly (No Parking, Handicap Transfer Zone);
- No. 684 - Ely side of Dupont Av N beg 244' Nly of the Nly curb line of Lowry Av N & th extending 38' Nly (No Parking, Handicap Transfer Zone);
- No. 685 - Wly side of Drew Av S beg 266' Sly of the Sly curb line of W 49th St & th extending 40' Sly (No Parking, Handicap Transfer Zone).

Section 2. That Section 478.590 of the above-entitled ordinance be amended by changing the following No Parking Zone:

- No. 6236 - No Parking, 2PM - 4PM, School Days ANYTIME, Nly side of E 24th St beg at the Wly curb line of Chicago Av S & th extending 240' Wly.

Section 3. That Section 478.730 of the above-entitled ordinance be amended by adding thereto the following Loading Zone:

No. 3253 - NWly side of 3rd Av N beg 22' SWly of the SWly curb line of Washington Av N & th extending 40' SWly (No Parking, Valet and Passenger Loading Zone, 6PM to 1AM, 30 Min Limit).

Section 4. That Section 478.730 of the above-entitled ordinance be amended by changing the following Loading Zones to read as follows:


No. 2836 - Both sides of 10th Av S betw the limits of E 25th St & E 26th St (Loading Zone Two ONE Hour Limit, 8AM - 6PM 8PM, Mon-Fri, Except by Permit);


No. 3003 - Both sides of E 25th S; betw the limits of 10th Av S & Chicago Av S (Loading Zone, Two ONE Hour Limit, 8AM - 6PM 8PM, Mon-Fri, Except by Permit).


