Amending Title 18, Chapter 478 of the Minneapolis Code of Ordinances relating to Traffic Code: Parking, Stopping and Standing.

The City Council of The City of Minneapolis do ordain as follows:

- Section 1. That Section 478.560 of the above-entitled ordinance be amended by adding thereto the following Handicap Transfer Zones:
 - No. 791 Ely side of Queen Av N beg 265' Nly of the Nly curb line of 14th Av N & th extending 40' Nly (No Parking, Handicap Parking Zone);
 - No. 792 Ely side of Colfax Av N beg 225' Nly of the Nly curb line of 27th Av N & th extending 40' Nly (No Parking, Handicap Parking Zone);
 - No. 793 Wly side of 26th Av S beg 538' Sly of the Sly curb line of E 57th St & th extending 38' Sly (No Parking, Handicap Parking Zone).
- Section 2. That Section 478.590 of the above-entitled ordinance be amended by adding thereto the following No Parking Zones:

 - No. 6414 Wly side of 34th Av S beg at the Sly curb line of E 51st St & th extending 75' Sly (No Parking Anytime);
 - No. 6415 Wly side of Chicago Av S beg 166' Sly of the Sly curb line of E 18th St & th extending 22' Sly (No Parking, Marked Police Vehicle Only);
 - No. 6416 SWIy side of 6th St N beg 49' SEly of the SEly curb line of 1st Av N & th extending 46' SEly (No Parking, Passenger and Valet Loading Zone, 6PM-1AM Daily, 30-Min Limit).

- Section 4. That Section 478.730 of the above-entitled ordinance be amended to change the following Loading Zone to read:
 - No. 3259 NETy side of 9th St S beg 325' NWTy from the NWTy curb line of LaSalle Av & th extending 44' NWly (Loading Zone, Commercial Trucks Only, 30-Min Limit, 8AM-64PM, Mon-Fri).
- Section 5. That Section 478.940 of the above-entitled ordinance be amended by adding thereto the following No Stopping Zones:
 - No. 110 Sly side of W Franklin Av beg 240' Ely of the Ely curb line of Dupont Av S & th extending Ely of Colfax Av S (No Stopping Anytime);
 - No. 111 Sly side of W Franklin Av betw the limits of Colfax Av S & Hennepin Av (No Stopping Anytime).
