Amending Title 20, Chapter 536 of the Minneapolis Code of Ordinances relating to Zoning Code: Zoning Districts and Maps Generally.

The City Council of The City of Minneapolis do ordain as follows:

Section 1. That Section 536.20 of the above-entitled ordinance be amended by changing the zoning district for the following parcel of land, pursuant to MS 462.357:

A. That part of the Southwest Quarter of the Southwest Quarter of Section 22, Township 29, Range 24, described as beginning at a point on the Northerly line of Auditor's Subdivision No. 31, Hennepin Cty, MN, distant 343.17 ft Easterly, measured along said Northerly line, from the Northwest corner of Lot 1, said Auditor's Subdivision No. 31; thence Easterly along said Northerly line and its extension a distance of 169.5'; thence Southerly deflecting to the right 82 degrees 48 minutes 10 seconds a distance of 108 ft; thence at a right angle West a distance of 4 ft; thence Southerly deflecting to the left 90 degrees, 37 minutes, 12 seconds a distance of 166.65 ft to the Northerly right-of-way line of Burlington Northern Inc.; thence Westerly along said Northerly right-of-way line a distance of 178.65 ft to an intersection with a line drawn South from the point of beginning and parallel with the West line of said Auditor's Subdivision No. 31; thence North along said parallel line a distance of 369.87 ft to the point of beginning (173 Glenwood Av N - Plate 13) to the B4H District.
