**Amending Title 18, Chapter 478 of the Minneapolis Code of Ordinances relating to Traffic Code: Parking, Stopping and Standing.**

The City Council of The City of Minneapolis do ordain as follows:

Section 1. That Section 478.590 of the above-entitled ordinance be amended by adding thereto the following No Parking Zones:

No. 6443 - NWly side of 4th Av S beg 26' SWly of the SWly curb line of 5th St S & th extending 120' SWly (No Parking, Police and Fire Marked Vehicles Only, 9AM-4PM & 6PM-7AM);

No. 6444 - SWly side of 5th St S beg 220' NWly of the NWly curb line of 4th Av S & th extending 100' NWly (No Parking, City Council Vehicles Only).

Section 2. That Section 478.590 of the above-entitled ordinance be amended to change the following No Parking Zones to read:

No. 3864 - NEly side of 5th St S beg 245' ~~261'~~ NWly of the NWly curb line of 4th St S & th extending ~~64'~~ 60' NWly (3 vehicles) (No Parking, Electronic News Media Vehicles Only);

No. 4759 - NEly side of 5th St S beg 223' ~~241'~~ NWly from the NWly curb line of 4th Av S & th extending ~~22'~~ 20' NWly (1 vehicle) (No Parking, Mayor's Vehicle Only);

No. 4760 - NEly side of 5th St S beg 201' ~~221'~~ NWly of the NWly curb line of 4th Av S & th extending ~~22'~~ 20' NWly (No Parking, City Council President's Vehicle Only);

No. 4767 - NEly side of 5th St S beg 110' ~~102'~~ NWly of the NWly curb line of 4th Av S & th extending ~~91'~~ 119' NWly (No Parking, City Council Vehicles Only);

No. 4106 - NEly side of 5th St S beg 22' NWly of the NWly curb line of 4th Av S & th extending 44' ~~80'~~ NWly (No Parking, Marked Fire Dept Vehicles Only);
