AN ORDINANCE of the CITY OF MINNEAPOLIS

presents the following ordinance:

Amending Title 18, Chapter 478 of the Minneapolis Code of Ordinances relating to Traffic Code: Parking, Stopping and Standing.

The City Council of The City of Minneapolis do ordain as follows:

Section 1. That Section 478.560 of the above-entitled ordinance be amended by adding thereto the following Handicap Transfer Zones:

- No. 816 - Sly side of Glenwood Av beg 72' Ely of the Ely curb line of Russell Av N (produced) & th extending 40' Ely (No Parking, Handicap Parking Zone);
- No. 817 - SEly side of 2nd Av N beg 302' NEly of the NEly curb line of 4th St N & th extending 22' NEly (No Parking, Handicap Transfer Zone).

Section 2. That Section 478.560 of the above-entitled ordinance be amended to change the following Handicap Transfer Zone to read:

- No. 356 - Sly side of W 41st St beg 90' 62' Ely of the curb line of Bryant Av S & th extending 40' Ely (No Parking, Handicap Transfer Zone).

Section 3. That Section 478.590 of the above-entitled ordinance be amended by adding thereto the following No Parking Zones:

- No. 6456 - Nly side of W 46th St beg at the Wly curb line of Aldrich Av S & th extending 45' Wly (No Parking Anytime);
- No. 6457 - Sly side of W 46th St beg at the Wly curb line of Aldrich Av S & th extending 45' Wly (No Parking Anytime);

No. 6458 - Nly side of W 46th St beg at the Ely curb line of Aldrich Av
S & th extending 45' Ely (No Parking Anytime);

No. 6459 - Sly side of W 46th St beg at the Ely curb line of Aldrich Av
S & th extending 45' Ely (No Parking Anytime).
