AN ORDINANCE TO HIRE A CPA FIRM TO CONDUCT A FORENSIC AUDIT ON THE OUTGOING ADMINISTRATION.

ST. BERNARD PARISH COUNCIL DOES HEREBY ORDAIN:

WHEREAS, the St. Bernard Parish Council believes it to be in the best interest of the citizens of St. Bernard Parish and St. Bernard Parish Government to hire an independent third party to audit certain financial records of St. Bernard Parish Government.

WHEREAS, the St. Bernard Parish Council may hire auditors under sec 2-09 of the Home Rule Charter.

SECTION 1. The St. Bernard Parish Council hereby empowers the vice chairman to represent the council in contract negotiations and execute a written contract or agreement with a third party auditor.

SECTION 2. The St. Bernard Parish Council hereby empowers the vice chairman to select an independent audit firm to audit, examine, and/or inspect all financial records of St. Bernard Parish.

SECTION 3. Effective Date. This Ordinance shall become effective immediately upon authorizing signature by the Parish President. In the event of a presidential veto, this Ordinance shall become effective upon a two-thirds favorable vote of the total membership of the Council pursuant to Sections 2-11 and 2-13 of the St. Bernard Parish Home Rule Charter.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:


