

RESOLUTION

WHEREAS, O.C.G.A. §32-4-40 authorizes the governing authority of Troup County, Georgia to designate roads as part of the county road system; and

WHEREAS, after public notice and hearing the Troup County Board of Commissioners believes that it is in the best interest of the public to rename certain portions of roads in unincorporated Troup County, to-wit: a portion of what was formerly New Franklin Road (SR 1, US 27) extending from the intersection of New Franklin Road (SR 1, US 27) to end of road as is shown and designated on the map and sketch attached hereto as Exhibit “A-1”; a portion of Hannah Road extending from the intersection of Hannah Road (CR 002) to end of road as is shown and designated on the map and sketch attached hereto as Exhibit “A-2”; a portion of what was formerly Hamilton Road (CR 1002, US 27) extending from the intersection of Hamilton Road (CR 1002, US 27) and looping back around to intersect with Hamilton Road as is shown and designated on the map and sketch attached hereto as Exhibit “A-3”; a portion of what was formerly New Franklin Road (SR 1, US 27) extending from the intersection of New Franklin Road (SR 1, US 27) to end of road as is shown and designated on the map and sketch attached hereto as Exhibit “A-4”; a portion of Mandy Brook Drive (CR 462A) extending from the intersection of Whitfield Road to the intersection of Briarwood Drive (CR 462) as is shown and designated on the map and sketch attached hereto as Exhibit “A-5”; and

WHEREAS, the Troup County Board of Commissioners deem it advisable to:

- (1) Change the name of that portion of what was formerly New Franklin Road (SR 1, US 27) extending from the intersection of New Franklin Road (SR 1, US 27) to end of road so that the same shall be henceforth be “Fernwood Drive”;
- (2) Change the name of that portion of Hannah Road extending from the intersection of Hannah Road (CR 002) to end of road so that the same shall henceforth be “Jones Brothers Drive”;
- (3) Change the name of that portion of what was formerly Hamilton Road (CR 1002, US 27) extending from the intersection of Hamilton Road (CR 1002, US 27) and looping back around to intersect with Hamilton Road so that the same shall henceforth be “Pleasant Grove Church Road”;
- (4) Change the name of that portion of what was formerly New Franklin Road (SR 1, US 27) extending from the intersection of New Franklin Road (SR 1, US 27) to end of road so that the same shall henceforth be “Robert Hayes Road”;
- (5) Change the name of that portion of Mandy Brook Drive (CR 462A) extending from the intersection of Whitfield Road to the intersection of Briarwood Drive (CR 462) so that the same shall henceforth be “Smokemont Drive”.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the portion of what was formerly New Franklin Road (SR 1, US 27), as shown on Exhibit “A-1” attached hereto, be and hereby is changed to **“Fernwood Drive”**; that the portion of Hannah Road, as shown on Exhibit “A-2” attached hereto, be and hereby is changed from Hannah Road to **“Jones Brothers Drive”**; that the portion of what was formerly Hamilton Road (CR 1002, US 27), as shown on Exhibit “A-3” attached hereto, be and hereby is changed

to **“Pleasant Grove Church Road”**; that the portion of what was formerly New Franklin Road (SR 1, US 27), as shown on Exhibit “A-4” attached hereto, be and hereby is changed to **“Robert Hayes Road”**; that the portion of Mandy Brook Drive (CR 462A) as shown on Exhibit “A-5” attached hereto, be and hereby is changed from Mandy Brook Drive to **“Smokemont Dive”**;

IT IS FURTHER RESOLVED that this Resolution shall be recorded in the minutes of the county and that these name changes shall be recorded on the official map of the county road system and the written record of the county road system.
