# ORDINANCE NO. 1524 -22

### AN ORDINANCE LEVYING AND ASSESSING TAXES FOR THE CITY OF AUBURN, ILLINOIS FOR THE YEAR ENDING DECEMBER 31, 2022 (PAYABLE IN 2023)

WHEREAS, on July 18, 2022, the City Council of the City of Auburn, Illinois passed and adopted an appropriations ordinance for the fiscal year ending April 30, 2023, which was duly signed and approved by the Mayor and recorded by the City Clerk, which specified in detail the purposes and amounts for which appropriations were made; and

WHEREAS, it has been and hereby is ascertained and declared that the total amount of all appropriations legally made and which is to be collected from the tax levy for the fiscal year amounts for park fund purposes.

NOW, THEREFORE, IT BE ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF AUBURN, ILLINOIS, that there be and is hereby levied upon all taxable property within the corporate limits of the City of Auburn, Illinois, subject to taxation for the fiscal year 2023, the sums for the following purposes:

SECTION ONE: A public parks tax in the sum of forty-six thousand dollars (\$46,000.00), is hereby levied and assessed upon all property subject to taxation within the City of Auburn, Illinois, as the same is assessed and equalized for State and County purposes.

SECTION TWO: Warrants against and in anticipation of the above levied taxes for the current year are hereby authorized to be drawn by the Mayor and the City Clerk and endorsed by the City Treasurer to the extent of seventy-five (75%) percent of the amount of said taxes.

SECTION THREE: The City Clerk shall forthwith file with the County Clerk of Sangamon County, Illinois, a certified copy of this ordinance and the County Clerk shall ascertain the rate per centrum upon which the total value of all property subject to taxation within the City of Auburn, as the same is assessed and equalized for State and County purposes for the current year, will produce the net amount levied and ordered certified and shall extend the tax on the tax books of the Collector of State and County taxes within said City as provided by the law.

SECTION FOUR: This Levy Ordinance is adopted pursuant to 65 ILCS 5/8-3-1 of the Illinois Municipal Code.

SECTION FIVE: If any item of the forgoing Ordinance shall, for any reason, be deemed invalid, it shall not be held to affect any validity of any other item or part of this Ordinance, which would otherwise be valid.

SECTION SIX: This ordinance shall take effect and be in full force from and after its passage, signing, and approval.
