

**A RESOLUTION TO ADOPT
THE 2022 SANGAMON COUNTY MULTI-JURISDICTIONAL NATURAL HAZARDS
MITIGATION PLAN UPDATE (the “PLAN”)
AS THE CITY’S MULTI-HAZARD MITIGATION PLAN**

WHEREAS, the City of Auburn (“City”), Sangamon County, State of Illinois, is a duly organized and existing City created under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code; and,

WHEREAS, the City recognizes the threat that natural hazards pose to people and property within the City of Auburn; and,

WHEREAS, the 2022 Sangamon County Multi-Jurisdictional Natural Hazards Mitigation Plan Update (hereinafter “the Plan”), has been prepared by the Springfield-Sangamon County Regional Planning Commission through the Sangamon County Multi-Jurisdictional Natural Hazards Mitigation Plan Task Force; and,

WHEREAS, the Plan has been prepared in accordance with FEMA requirements at 44 CFR Part 201; and,

WHEREAS, the Plan identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in the City from the impacts of future hazards and disasters; and,

WHEREAS, adoption by the City’s corporate authorities demonstrates the City’s commitment to the hazard mitigation and achieving the goals outlined in the Plan; and,

WHEREAS, the City is a local unit of government that has afforded the citizens an opportunity to comment and provide input to the Plan and the actions in the Plan; and,


WHEREAS, the City has reviewed the Plan and affirms to participate in the Workgroup that will review the Plan every year and update it no less than every five years.
