ORDINANCE 2025-01

AN ORDINANCE OF THE CITY COMMISSION FOR THE CITY OF PALMETTO, FLORIDA, AMENDING THE PALMETTO CODE OF ORDINANCES; AMENDING REGULATIONS RELATED TO THE MEMBERSHIP AND TERMS OF OFFICE FOR THE **PALMETTO** COMMUNITY REDEVELOPMENT ADVISORY BOARD; AMENDING PURPOSE AND DUTIES OF THE COMMUNITY REDEVELOPMENT AGENCY ADVISORY BOARD; PROVIDING FOR REPEAL OF ORDINANCES IN **SEVERABILITY**; **FOR** AND CONFLICT; PROVIDING PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Article VIII, Section 2 of the Florida Constitution provides that municipalities shall have governmental, corporate and proprietary powers to enable municipalities to conduct municipal government, perform municipal functions and render municipal services; and,

WHEREAS, pursuant to the referenced provision of the Florida Constitution, a city may exercise any power for municipal purposes except as otherwise provided by law; and,

WHEREAS, Chapter 166, Florida Statutes, the "Municipal Home Rule Powers Act," implements the applicable provisions of the Florida Constitution and authorizes municipalities to exercise any power for municipal purposes, except when expressly prohibited by law and to enact ordinances in furtherance thereof; and,

WHEREAS, it has been over fifteen years since the establishment of the Palmetto Community Redevelopment Agency Advisory Board ("CRAAB");

WHEREAS, the City Commission has held one or more workshop and public hearing on the issue; and

WHEREAS, the City Commission desires amendments to provide a more diversified Board and address operational issues raised by having only a three member Board; and

WHEREAS, the City Commission desires to clarify and amend the powers and duties of the CRAAB; and

WHEREAS, consistent with the findings stated above, the City Commission has determined that adoption of this ordinance is in the best interest of the public health, safety and welfare of the citizens of the City of Palmetto.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PALMETTO, FLORIDA, as follows:

- Section 1. Findings of Fact. The above "WHEREAS" clauses are adopted herein as findings of fact.
- Section 2. Code Language and Effect on Other Subsection Language. Section 11-81 of the Palmetto Code of Ordinances is amended to read in its entirety as follows:
 - A. Section 11-81 is hereby amended to read in its entirety as follows:

Section 11-81. - Establishment and composition.

- (a) <u>Board Composition</u>. The Community Redevelopment Agency Advisory Board is hereby established and shall consist of five (5) members to be appointed by the mayor and approved by a majority vote of the City Commission.
- Any person may be appointed as a member of the board if he or she resides in the City of Palmetto. The membership qualifications listed above may be waived by the Mayor and City Commission in the event there is a desire to appoint an individual who does not fit into one of the above categories but is someone whom nonetheless would be an asset to the Advisory Board.
- (b) <u>Terms</u>. Subject to the requirements of the City Charter, the terms of office shall be for two (2) years with no more than two (2) full terms permitted. Any vacancy

occurring during the term of any member of the board shall be filled for the unexpired portion of the term.

- (c) Attendance and Removal. It is the intent and strong desire of the City Commission that there be full attendance of Advisory Board members at all scheduled meetings of the Advisory Board, recognizing, however, that it may be necessary for board members to be absent from a meeting due to unusual or emergency circumstances. The Advisory Board shall be subject to the City's policy for attendance and removal of advisory board members set forth in Section 11-82 of the City Code.
- B. Section 11-84 is hereby amended to read in its entirety as follows:

Section 11-84 - Purpose and Duties.

- (a) The Advisory Board shall be the primary source of community input to the Community Redevelopment agency and to the Agency staff regarding community redevelopment activities to be undertaken within the Palmetto Community Redevelopment Area. The Advisory Board functions are advisory only and are to assist with public input in the local redevelopment planning process.
- (b) The purpose and duties of the Advisory Board shall be as follows:
 - 1. To view proposed public-private redevelopment projects and recommend to the Agency whether financial or other assistance should be provided to any such project;
 - 2. To review the proposed annual work program and make recommendations to the Agency concerning such program, recommend project priorities to the Agency, and recommend incentives to further the

redevelopment efforts and carry out and effectuate the purposes and provisions of the Redevelopment Act;

- 3. To develop, review, and make recommendations concerning Requests for Proposals for redevelopment projects in the Community Redevelopment Area;
- 4. Review the proposed CRA Plan and provide advise and recommendations to the Agency on the plan;
- 5. To receive comments from members of the public interested in redevelopment of the Community Redevelopment Area and to report such information to the Agency; and
- 6. To consider any matters or duties referred to the Advisory Board by the Agency.
- Section 3. Repeal of Inconsistent Ordinances. This Ordinance hereby repeals all ordinances, or parts thereof, in conflict herewith to the extent of such conflict.
- Section 4. Severability. If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared severable.
- Section 5. Effective Date. This Ordinance shall take effect as provided for by law and by City Charter, Section 14, upon execution by the Mayor or, if disapproval occurs, upon reconsideration by the City Commission and passing of the Ordinance by at least four (4) votes.


