



## **ORDINANCE NO. 23-0919-G10**

**AN ORDINANCE OF THE CITY OF ENNIS, TEXAS REPEALING IN ITS ENTIRETY ORDINANCE NO. 23-0905-G4; AMENDING CHAPTER 2 'ADMINISTRATION', ARTICLE 1 'IN GENERAL', SECTION 2-1 'MUNICIPAL FEE AND USE SCHEDULE' OF THE CODE OF ORDINANCES; ADOPTING A NEW SCHEDULE OF FEES FOR MUNICIPAL SERVICES FOR FY24; PROVIDING FOR A SAVINGS CLAUSE; PROVIDING FOR A CUMULATIVE/REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE.**

**WHEREAS,** The City of Ennis City Commission approved Ordinance No. 23-0905-G4, adopting a Municipal Fee Schedule, on September 5, 2023 at a Regular Meeting of the City Commission, and

**WHEREAS,** corrections to the adopted Fee Schedule are found to be necessary; and

**WHEREAS,** the City Commission wishes to replace Ordinance No. 23-0905-G4 with this Ordinance, and adopt a new Municipal Fee Schedule for FY 24 attached as 'Exhibit A'.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF ENNIS, TX:**

**SECTION 1:** The findings set forth above are incorporated as if fully set forth herein.

**SECTION 2:** Ordinance No. 23-0905-G4 is hereby repealed in its entirety.

**SECTION 3:** Chapter 2 'Administration', Article I 'In General', Section 2-1 'Municipal Fee and Use Schedule' shall be amended to reflect the attached "Exhibit A" Fee Schedule for FY2024.

**SECTION 4: Savings Clause.** All rights and remedies of the City of Ennis, Texas, are expressly saved as to any and all violations of the provisions of the Ordinance or any other ordinance which have accrued at the time of the effective date of this Ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances, same shall not be affected by this Ordinance but may be prosecuted until final disposition by the courts.

**SECTION 5: Cumulative/Repealer Clause.** This Ordinance shall be cumulative of all provisions of state or federal law and other ordinances of the City of Ennis, Texas, except where the provisions of this Ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

**SECTION 6: Severability Clause.** It is hereby declared to be the intention of the City Commission that the phrases, clauses, sentences, paragraphs and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the City Commission without the incorporation of this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

**SECTION 7: Effective Date.** This Ordinance shall take effect on October 1, 2023 and will be published as required by Texas law and the City Charter.
