

**ORDINANCE NO. 1860**

**ORDINANCE AMENDING SECTION 66 CONCERNING THE BUSINESS LICENSE  
CODE OF THE NORTHPORT CITY CODE**

WHEREAS, Section 66 of the Northport City code provides for the classification of business license in the City of Northport; and

WHEREAS, the City of Northport wishes to add 66-300 describing the procedure for issuing taxi, limousine and shuttle business licenses and to update the classifications schedules in 66-292 to include classification not included in the Code of Ordinance of the City of Northport, Alabama (“Code”) related to business license Code; and

WHEREFORE, this Ordinance shall become effective immediately upon its passage or otherwise becoming law.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHPORT, ALABAMA,** and Section 66-292 and 66-300 of the Northport City Code to read as follows:

**Section 66-292 of the Code of the City of Northport by adding the following:**

**66-300 Taxicab, Limousine, and Shuttle Service Licenses:**

- (a) Each taxicab/limousine/shuttle **company** located in the City Limits of Northport or it’s Police Jurisdiction will need to purchase the Taxicab/Limousine/Shuttle Company License using Schedule “A” based on total gross receipts plus the Taxicab Owner License using schedule “J” based on number of cars running in Northport and it’s Police Jurisdiction and show proof of each vehicle being inspected by the Police Department, plus each driver will be required to purchase the Taxicab Driver Permit at a flat rate of \$35. The company can pay this fee for their driver if they choose to but each driver must go through the police department for their Driver’s Certificate.
- (b) Each **owner** of a taxi/limousine/shuttle that operates in the City of Northport will purchase the Taxicab/Limousine/Shuttle Owner License using Schedule “J” and the

Taxicab Driver Permit at a flat fee of \$35. and must go to the Police Department for their Driver's Certificate and show proof of each vehicle being inspected by the Police Department.

- (c) If a **driver** is contracted (not employed) by a taxicab/shuttle/ limousine company to drive the company's vehicles they will purchase the Taxicab/Limousine/Shuttle Driver Permit for a flat fee of \$35. The company may choose to pay for this permit for the driver but each driver must go through the police department for their Driver's Certificate.
