

ORDINANCE #1120

AN ORDINANCE DECLARING RESULTS OF MUNICIPAL ELECTION HELD ON APRIL 4, 2023, FOR THE PURPOSE OF ELECTING MAYOR AND TWO ALDERMEN, ONE FROM THE EAST WARD AND ONE FROM THE WEST WARD IN THE CITY OF AVA, MISSOURI.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF AVA, MISSOURI, THAT:

Section 1. A municipal election was held in the City of Ava, Missouri, on April 4, 2023, for the purpose of electing Mayor and two aldermen, one from the East Ward and one from the West Ward.

Section 3. This ordinance shall become effective and in force from and after its passage and approval by the Board of Aldermen of the City of Ava, Missouri.


