AN ORDINANCE AMENDING CHAPTER 94, ARTICLE IV., STOPPING, STANDING OR PARKING, DIVISION 1. SECTION 94-188, "SNOW ON STREETS", AND AMENDING CHAPTER 1 GENERAL PROVISIONS, SECTIONS 1-9A AND 1-9F "CITATIONS" OF THE REVISED MUNICIPAL CODE OF THE VILLAGE OF NORRIDGE – 2002

An Ordinance Regulating Snow Route Parking on Village Streets

WHEREAS, the Village of Norridge ("Village"), as a home rule municipality in accordance with Article VII Section 6(a) of the Constitution of the State of Illinois of 1970, is enacting this Ordinance pursuant to its home rule authority; and

WHEREAS, the regulation of parking in the Village is a matter which pertains to the Village's government and affairs; and

WHEREAS, the Village Board of Trustees ("Village Board") has previously adopted regulations governing parking during the winter season to provide for the safe and efficient cleaning of Village streets following a snowfall; and

WHEREAS, after consultation with the Village Public Works officials who are recommending changes to the Village's current parking regulations as affecting snow removal, the Village Board wishes to update the current snow removal parking regulations as set forth herein and amend the corresponding General Provisions set forth in Chapter 1, Section 1-9 A and F of the Revised Municipal Code of the Village of Norridge – 2002 ("Code"); and

WHEREAS, the Village Board finds it to be in the best interests of the Village to amend the Code by enacting the regulations set forth below regarding snow route parking for benefit of the health, safety and welfare of the citizens of the Village.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF NORRIDGE, COOK COUNTY, ILLINOIS, as follows:

Section 1.

The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section 2.

That Chapter 94, Section 94-188 of the Revised Municipal Code of the Village of Norridge – 2002 is be and hereby is amended as set forth herein:

Sec. 94-188. - Snow on streets.

- A. It shall be unlawful, where parking is not otherwise prohibited, for any person to stop, stand or park or leave unattended a motor vehicle on any public street in the village, after two (2) inches of snow have fallen, until the snow has been removed. Regulations governing parking for snow removal for specific streets, areas, and times are set forth in Section B, herein.
- B. Snow on Streets; Snow route parking prohibited in specific locations and times. It shall be unlawful, where parking is not otherwise prohibited for any person to stop, stand, or park a vehicle, or leave unattended a motor vehicle on the following designated Snow Routes after two (2) inches of snow has fallen until the snow has been removed. These regulations shall be in effect from October 1 until April 15 each year.
 - 1. Snow route on both sides of the street (effective October 1, 2020):
 - a. On the 7000 and 7100 blocks of Windsor Avenue.
 - b. On the 4300, 4400 and 4500 blocks of Nottingham Avenue.
 - c. On the 4300 block of Nordica Avenue.
 - d. On the 7000 block of Pensacola Avenue.
 - e. On the 4400, 4500, 4600 and 4700 blocks of Canfield Road.
 - f. On the 4400 and 4500 blocks of Oketo Avenue.
 - 2. Snow route on the odd (address) side of the street (effective October 1, 2021):
 - a. On the 7000 block of Cullom Avenue.
 - b. On the 8200 and 8300 blocks of Foster Avenue.
 - 3. Snow route on the even (address) side of the street (effective October 1, 2021):

On the 7200 through 7300 blocks of Agatite Avenue.

- 4. Snow route on the following streets from 8:00 a.m. 1:00 p.m. for the side of the street with even street addresses on even calendar dates, and for the side of the street with odd street addresses on odd calendar dates, after two (2) inches of snow has fallen. These regulations shall be in effect from October 1 until April 15 each year. (effective October 1, 2021).
 - a. On the 7600 block of Strong Avenue.
 - b. On the 7600 block of Norridge Avenue.
 - c. On the 7600 block of Ainslie Avenue.
 - d. On the 7600 block of Gunnison Avenue.
 - e. On the 7000 and 7100 blocks of Sunnyside Avenue.
 - f. On the 7000 and 7100 blocks of Agatite Avenue.
 - g. On the 7000 and 7100 blocks of Montrose Avenue.
 - e. On the 4300 block of Neva Avenue.
 - f. On the 7100 block of Pensacola Avenue.
 - g. On the 4200 block of Sayre Avenue.
- 5. Snow route on the following streets from 8:00 a.m. 1:00 p.m. for the side of the street with even street addresses on even calendar dates, and for the side of the street with odd street addresses on odd calendar dates, after two (2) inches of snow has fallen. These regulations shall be in effect from October 1 until April 15 each year. (effective October 1, 2021).
 - a. Entire Historical Section: 4000, 4100, 4200, 4300 blocks of Ozanam, Ozark, Overhill, Ottawa, Oriole, Oleander, Olcott, Osceola, Oketo, Odell, and Octavia (lying between Irving Park Road to Montrose Avenue from Ozanam Avenue to Harlem Avenue).
 - b. On the 7200-7300 blocks of Pensacola Avenue (from Harlem to Oketo).
 - c. On the 7200-7700 blocks of Cullom Avenue (from Harlem to Ozanam).
 - d. On the 7300-7700 blocks of Berteau Avenue (from Octavia to Ozanam).

- e. On the 7300-7700 blocks of Belle Plaine Avenue (from Octavia to Ozanam).
- f. On the 7200-7700 blocks of Montrose Avenue (from Harlem to Ozanam).
- 6. Snow route on the even (address) and/or west side of the street from 8:00 a.m. 1:00 p.m. after two (2) inches of snow has fallen. These regulations shall be in effect from October 1 until April 15 each year. (effective October 1, 2021)
 - a. On the 4200 block of Newland Avenue.
 - b. On the 4300, 4400, and 4500 blocks of Sayre Avenue.
- C. All motor vehicles in violation of the provisions of this section will be subject to being towed away at the owner's expense.

Section 3.

That Chapter 1, Section 1-9 of the Revised Municipal Code of the Village of

Chapter 1 - GENERAL PROVISIONS

Sec. 1-9. - Citations.

- A. A police officer may, in lieu of the filing of a complaint in court for a violation of this Code, in the first instance, issue to such alleged violator a citation by citing the violation on the appropriate village complaint form:
 - 1. Advising the person that he has violated a specific ordinance;

Norridge – 2002 is be and hereby is amended as set forth herein:

- 2. Requesting that the person make payment in an amount applicable to such alleged violation as set forth in subsection F.1. of this section as settlement of such violation claim; and
- 3. Informing the person that upon failure to so settle, the alleged offender's name and violation, along with any other appropriate information, will be given to a reputable collection agency, which shall be engaged to collect such fines, plus costs, after such person has failed to settle the alleged violation as set forth in subsection F.1. of this section with the village.
- B. Pursuant to the citation, the person so accused of the violation may settle and compromise the violation claim regarding such ordinance violation by paying to the village the applicable amount as shown in the schedule set forth in subsection F.1. of this section, within a period to be specified in the citation (due date), not more than ten days from the time the alleged offense was committed.

- C. Pursuant to 65 ILCS 5/1-2-8, the payment of fines, penalties and forfeitures shall be made in accordance with the instructions contained in the citation, at the office of the village clerk, who shall issue a receipt of payment for the money so received and promptly remit such amount to the village treasurer to be credited to the proper village fund.
- D. If the person to whom the citation is issued fails to settle and pay such violation claim within the prescribed time (due date), or within an extended ten-day period of time specified in the final notice, then the village shall be authorized to file and submit the alleged violator's name and violation, along with any other appropriate information, to a reputable collection agency, wherein the payment of any fine, plus costs, shall be in such amounts as have been determined and established by the village.
- E. The fact that an automobile or motor vehicle which is illegally operated or parked is registered with the secretary of state in the name of the alleged violator; or in the alternative, if a vehicle sticker issued in the name of and/or to the alleged violator, shall be considered prima facie evidence that the alleged violator was in control of or was the operator of the automobile or motor vehicle at the time of such alleged violation; provided, however, that no person who is the lessor of a vehicle pursuant to a written lease agreement shall be liable for the violation of any parking or standing regulation involving such vehicle during the period of the lease, provided that upon the request of the village received within 120 days after the violation occurred, the lessor provides within 60 days after such receipt the name and address of the lessee.
- F. The violation claim described in such citation so to be issued pursuant to the terms of this section, may be settled, compromised, and paid in the respective amounts set forth in the following schedule. Each day the violation continues is a separate offense.

Section 4.

All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

Section 6.

If any provision of this Ordinance, or the application of any provision of this Ordinance, is held unconstitutional or otherwise invalid, such occurrence shall not affect other provisions of this Ordinance or their application if they can be given effect without the unconstitutional or invalid provision or its application. Each unconstitutional or invalid provision is severable, unless otherwise provided by this Ordinance.
