ORDINANCE NO. 2140

**ORDINANCE TO REPEAL ARTICLE VII OF CHAPTER 66 OF THE CODE OF
ORDINANCES OF THE VILLAGE OF MIDDLEVILLE RELATING TO OPERATION
OF OFF-ROAD VEHICLES WITHIN THE VILLAGE**

THE VILLAGE OF MIDDLEVILLE HEREBY ORDAINS:

Section 1. **Repeal of Ordinance.** Article VII of Chapter 66 of the Code of Ordinances of the Village of Middleville, pertaining to the regulation of Off-Road Vehicles, adopted on June 22, 2021, is hereby repealed.

Section 2. **Severability.** The provisions of this ordinance are hereby declared to be severable. If any clause, sentence, word, section, or provision is hereafter declared void or unenforceable for any reason by a court of competent jurisdiction, it shall not affect the remainder of this ordinance, which shall continue in full force and effect.

Section 3. **Repeal.** All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.


Section 3. **Publication; Effective Date.** This Ordinance shall become effective upon its publication or upon the publication of a summary of its provisions in a local newspaper of general circulation in the Village.
