

**CITY OF PARCHMENT

SUMMARY OF ORDINANCE 220**

On June 21, 2021, the City of Parchment, Kalamazoo County, Michigan, enacted Ordinance 220, known as the City of Parchment Mill Planned Unit Development (PUD) District Ordinance. A summary thereof follows:

**ORDINANCE 220**

**AN ORDINANCE TO AMEND THE PARCHMENT CITY CODE OF ORDINANCES TO AMEND ARTICLE 20 OF THE PARCHMENT CITY ZONING ORDINANCE (APPENDIX A), TO ADD DEFINITIONS OF INDOOR FARMING AND URBAN FARMING; TO ADOPT AN ORDINANCE ESTABLISHING RULES AND REGULATIONS FOR A NEW ZONING DISTRICT (MILL PLANNED UNIT DEVELOPMENT (PUD) DISTRICT; TO ADD NEW REGULATIONS AND STANDARDS FOR DWELLINGS; TO AMEND THE PARCHMENT ZONING MAP TO REZONE CERTAIN MILL PROPERTIES FROM I-M INDUSTRIAL DISTRICT TO MILL PLANNED UNIT DEVELOPMENT (PUD) DISTRICT; TO REPEAL ALL OTHER ORDINANCES OR PARTS THEREIN INCONSISTENT OR CONTRARY TO THIS ORDINANCE; AND TO ESTABLISH AN EFFECTIVE DATE FOR THIS ORDINANCE.**

ARTICLE I

Article 2, Section 2.2, is amended to add definitions for Indoor Farming and Urban Farming.

ARTICLE II

Creates Article 11A - Mill Planned Unit Development (PUD) District, Sections 11A.1 through 11A.9.

ARTICLE III

Article 12, General Provisions, Section 12.2, Building Regulations, is amended to add a new Section 7 setting regulations for dwellings.

#### ARTICLE IV

The Parchment City Zoning Map is amended to rezone the following properties from IM-Industrial Manufacturing District to Mill Planned Unit Development (PUD) District:

#### ARTICLE V - REPEALER

Repeals all Ordinances or parts thereof in conflict herewith.

#### ARTICLE VI - SEVERABILITY

Provides that should any provision be held void or unenforceable, it shall be deemed severable.

#### ARTICLE VII - EFFECTIVE DATE

Provides that the Ordinance shall take effect 30 days after publication.
