ORDINANCE NO. 06-20

AN ORDINANCE REPEALING ARTICLE II, SECTIONS 14-51 AND 14-55
AND 14-82(C through H) AND 14-84 THROUGH 14-87 OF THE SALLISAW CODE,
ADDING NEW SECTIONS14-51 AND 14-55 AND 14-82(C through F) AND 14-84
THROUGH 14-85 PROVIDING FOR THE RULES AND REGULATION OF
STANDARDS GOVERNING AERONAUTICAL ACTIVITIES

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF SALLISAW, OKLAHOMA:

SECTION 1.

The Sallisaw Code be amended by striking and repealing therefrom the present Sections 14-51, 14-55, 14-82(C through H), 14-84 through 14-87.

SECTION 2.

Sections 14-51, 14-55, 14-82(C through F), 14-84 and 14-85 of the Sallisaw Code is hereby created to read as follows:

SECTION 14-51: Established.

The city airport advisory board shall consist of a chair, a vice-chair, a secretary and two members. Airport advisory board members shall be appointed by the mayor and the appointments confirmed by the board of commissioners. Not less than two members of the advisory board shall be pilots. For the purposes of this division, the term "pilot" is defined as a person having a pilot certificate. (Code 1994, § 16-101)

SECTION 14-55: Applicable rules.

- (a) The airport advisory board shall comply with all laws, rules, ordinances and regulations of the federal government and city applicable to the municipal airport in the conduct of airport advisory board business. A majority of three airport advisory board members must be present at a meeting to conduct business.
- (b) Advisory board members are expected to attend all meetings. In the event a member's attendance becomes an issue, the advisory board may make a recommendation to the City Commission for removal of such member. (Code 1994, § 16-105)

SECTION 14-82: General airport rules.

- (c) All entrance gates to the aircraft parking ramp area shall be kept closed. Any person using the gates shall determine that they are left securely closed.
- (d) All field entrance vehicle gates must be closed and locked during the hours of darkness. After gates are closed and locked each night by the airport watchman, any person entering or leaving the field through such gates shall leave the gate closed and locked.
- (e) Vehicles and pedestrians on the landing areas are limited to those under the control of the airport manager or airport operator or to such vehicles or pedestrians that have received permission from the airport manager or airport operator as being necessary for proper conduct of airport business, maintenance, repairs, or inspection. Such authorized vehicles while on the field are required to display a checkered or red flag three feet square.
- (f) Any person, corporation, or company damaging or destroying airport property, either by accident or otherwise, shall reimburse the city for the reasonable value of the repair or replacement of the property damaged or destroyed. (Code 1994, § 16-111)

SECTION 14-84: Traffic rules.

The air traffic rules promulgated by Federal Aviation Administration and presently in effect are hereby referred to, adopted, and made a part of this division as fully in all respects as if particularly set forth in this division. (Code 1994, § 16-114)

SECTION 14-85: Penalty.

Any person violating or failing to comply with any of the provisions of this article shall, upon conviction thereof, be punished as provided in section 1-8. Each day, or part of a day, of such violation shall constitute a separate offense. (Code 1994, 16-116)

WHEREAS, an emergency and immediate necessity exists by reason of the health, safety and protection of the citizens of Sallisaw; therefore, an emergency is declared to exist by reason whereof this ordinance shall be in full force and effect from and after its passage and approval.
