

ORDINANCE NO. 2017-11

AN ORDINANCE TO AMEND VILLAGE ORDINANCE TO COMBINE THE OFFICES OF CLERK AND TREASURER

Purpose: In the past, Village Staff had special skills making it appropriate for the Village Administrator to serve as Treasurer. Prior to that time, one official served as the Village Clerk-Treasurer. The Village Board wishes to restore having the same individual serving as Village Clerk and Village Treasurer.

The Village Board of the Village of McFarland do hereby ordain as follows:

1. Section 2-509(a)(1) of the McFarland Municipal Code is hereby amended to read as follows:

“(1) Village Clerk-Treasurer”

2. Section 2-509(a)(2) of the McFarland Municipal Code is hereby repealed and Section 2-509(a)(3) is hereby renumbered as Section 2-509(a)(2).

3. Section 2-515(Title) of the McFarland Municipal Code is hereby amended to read as follows:

“Sec.2-515 Village Clerk-Treasurer and Deputy Village Clerk.”

4. Section 2-515(a) of the McFarland Municipal Code is hereby repealed and replaced as follows:

“(a) ~~Consolidated offices. Appointment. Pursuant to Section 2-509 and Wis. Stats. §§ 61.195, 61.197 and 66.0101,~~ The office of Village Clerk-Treasurer shall be filled by appointment by the Village President subject to confirmation by the Village Board. The Village Clerk-Treasurer shall have the duties and responsibilities set forth in Wis. Stats. § 61.25 and §61.26 in addition to any duties and responsibilities set forth in this Code. The Village Clerk-Treasurer shall hold office for an indefinite term, subject to removal by a vote of the Village Board.”

5. Section 2-515(b) of the McFarland Municipal Code is hereby amended to read as follows:

“(b) Deputy Village Clerk. There shall be a Deputy Village Clerk. The Deputy Village Clerk shall assist the Village Clerk-Treasurer in performing the duties of that office under Wis. Stats. §61.25 and clerk duties under this Code.”

6. Section 2-516(b) of the McFarland Municipal Code is hereby renumbered as Section 515(c) and is amended to read as follows:

“(c) Deputy Village Treasurer. There shall be a Deputy Village Treasurer, ~~which office shall be filled by the Village Clerk.~~ The Deputy Village Treasurer shall assist and work under the direction of the Village Clerk-Treasurer in performing the duties of that office under Wis. Stats. §61.26 and treasurer duties under this Code.”

7. Section 2-576 of the McFarland Municipal Code is hereby repealed.
