

ORDINANCE NO.: 20-04

AN ORDINANCE OF BAY COUNTY, FLORIDA AMENDING BAY COUNTY CODE SECTION 25-126 REGARDING STORMWATER UTILITY FEES THAT PROVIDES AN EXEMPTION FOR THE HOMESTEAD OF A PERSON WHO HAS A TOTAL AND PERMANENT DISABILITY AS A RESULT OF ANY INJURY SUSTAINED IN THE LINE OF DUTY WHILE SERVING AS A FIRST RESPONDER.

BE IT ORDAINED by the Board of County Commissioners of Bay County, Florida as follows:

SECTION 1. AMENDMENT. Chapter 25, Article III, Section 25-126 (b) (5) of the Bay County Code is amended as set forth below with underlined text as an addition to the exemptions from imposition of the stormwater utility fee:

(5)

e. The homestead of any individual who annually qualifies for the disabled first responder ad valorem homestead exemption under F.S. § 196.102.

SECTION 2. SEVERABILITY. It is hereby declared to be the intent of the Board of County Commissioners of Bay County, Florida that if any section, subsection, clause, phrase, or provision of this Ordinance is held invalid or unconstitutional, such invalidity or unconstitutionality shall not be construed as to render invalid or unconstitutional the remaining provisions of this Ordinance.

SECTION 3. REPEAL. All ordinances or parts of ordinances in conflict with this ordinance are to the extent of such conflict hereby repealed.



SECTION 5. EFFECTIVE DATE. This Ordinance shall take effect when filed with the Department of State.






**RESOLUTION NO. 3681**

**A RESOLUTION OF THE BAY COUNTY BOARD  
OF COUNTY COMMISSIONERS AUTHORIZING  
AN APPLICATION TO THE NATIONAL PARK  
SERVICE TO ACQUIRE THE PROPERTY  
LOCATED AT 8525 SURF DRIVE FOR  
RECREATIONAL PURPOSES**

**WHEREAS**, certain real property owned by the United States of America, located in Bay County, Florida, has been declared surplus and, at the discretion of the General Services Administration, may be assigned to the Secretary of the Interior for disposal for public park or recreational purposes under the provisions of 40 U.S.C. § 550 (e), and any regulations and policies promulgated pursuant thereto, more particularly described as follows:

Former Naval At Sea Testing Site 0.31 Acres Vacant Land, 8525 Surf Drive, Bay County, Panama City, Florida 32408, of approximately 0.31 acres, General Services Administration Control Number: 4-N-FL-1343-AA

**WHEREAS**, Bay County, Florida, needs and will use said property in perpetuity for public park or recreational purposes as set forth in its application and in accordance with the requirements of said Act and any regulations and policies promulgated thereunder;

**NOW, THEREFORE, BE IT RESOLVED, THAT**

1. The County Manager, on behalf of the Bay County Board of County Commissioners, shall make application to the National Park Service for, and secure the transfer to, the above-mentioned property for said use and subject to such exceptions, reservations, terms, covenants, agreements, conditions, and restrictions as the National Park Service and the Federal disposal agency may require in connection with the disposal of said property under said Act and the regulations and policies issued pursuant thereto.

2. The Bay County Board of County Commissioners has legal authority, and is willing and able, to properly develop, maintain, operate, and assume liability of the property, and that the County Manager is hereby authorized, for and on behalf of the Bay County Board of County Commissioners to do and perform any and all acts and things which may be necessary to carry out the foregoing resolution, including the preparing, making, and filing of plans, applications, reports, and other documents, the execution, acceptance, delivery, and recordation of agreements, deeds, and other instruments pertaining to the transfer of said property, including the filing of copies of the application and the conveyance documents in the records of the governing body, and the payment of any and all sums necessary on account of the purchase price thereof or fees or costs incurred in connection with the transfer of said property for survey, title searches, recordation or instruments, or other costs identified with the acquisition of said property.

3. The application previously filed by the County Manager for the acquisition of this property is hereby ratified and confirmed.
4. This Resolution shall become effective upon adoption.
