

ORDINANCE NO. 2238-21

AN ORDINANCE OF THE CITY OF SYLACAUGA, ALABAMA, TO EXEMPT CERTAIN "COVERED ITEMS" FROM MUNICIPAL SALES AND USE TAX DURING THE LAST FULL WEEKEND OF FEBRUARY, 2022, AS AUTHORIZED BY THE SEVERE WEATHER PREPAREDNESS SALES TAX HOLIDAY ACT 2012-256.

BE IT ORDAINED BY THE CITY COUNCIL OF SYLACAUGA, ALABAMA, AS FOLLOWS:

Section 1. In conformity with the provisions of the State of Alabama Legislative Act 2012- 256, Rule 810-6-3-.66-.02ER, Sales Tax Holiday for Severe Weather Preparedness, the City of Sylacauga, Alabama, exempts "covered items", as published on the Alabama Department of Revenue's website, from municipal sales and use tax during the same period, beginning at 12:01 a.m. on the last Friday in February 2022 (February 25, 2022) and ending at twelve midnight the following Sunday (February 27, 2022).

Section 2. This ordinance shall be subject to all terms, conditions, definitions, time periods, and rules as provided by the act, except that the time period shall only be as specified above and not for all years thereafter.

Section 3. The City Clerk is hereby authorized and directed to certify a copy of this ordinance under the seal of the City of Sylacauga, Alabama, and to forward said certified copy to the Alabama Department of Revenue to be recorded and posted on the Department website.

Section 4. This ordinance shall become effective on February 1, 2022, and the exemptions provided herein shall only be in effect during the timeframe specified above.

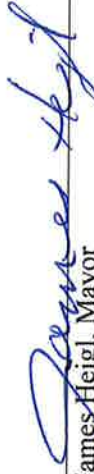

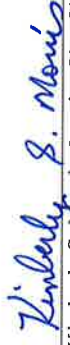

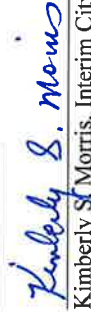
