## ORDINANCE NO. 16-2016

## CITY OF SHELBY FY 2015-2016 BUDGET ORDINANCE AMENDMENT

WHEREAS, in accordance with applicable provisions of the North Carolina Budget and Fiscal Control Act the City of Shelby finds it advisable and necessary to revise and amend its annual budget for FY 2015-2016; and,

WHEREAS, the City Manager (Budget Officer) has recommended certain amendments to the budget which the governing body finds acceptable; and,

WHEREAS, City Council now desires to act on the recommended budget amendments and approve same for implementation and compliance with the Fiscal Control Act;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHELBY, NORTH CAROLINA:

<u>Section 1</u>. Ordinance No. 32-2015, the City's FY 2015-2016 Budget Ordinance, is hereby amended as follows to provide for Budget Amendment No. 18 for the year:

- (A) The City of Shelby, via Resolution 04-2013, approved incentive agreements and awarded Industrial Incentive Grants to KSM Castings NC Inc. KSM Castings NC Inc. has now met the requirements for distribution of grant funds for the second year of their incentive. Accordingly, the following budget modifications are approved in accordance with the chart of accounts heretofore established for the City of Shelby.
  - (1) The following General Fund line items are amended:
