

ORDINANCE NO 2014-2464

AN ORDINANCE OF THE CITY OF WHITE SETTLEMENT AMENDING CHAPTER 22 OF THE CODE OF ORDINANCES; AMENDING ARTICLE 22.6 ANIMAL CONTROL SERVICES AND ARTICLE 22.7 PARKS AND RECREATION SERVICES; PROVIDING FOR PENALTIES; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; PROVIDING A SAVINGS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR PUBLICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of White Settlement has previously amended the Code of Ordinances by enumerating all city fees in a single location, as reflected in Chapter 22 of the Code of Ordinances; and

WHEREAS, the City Council of the City of White Settlement now deems it appropriate to amend Section 22.6 and 22.7 of Chapter 22 of the Code of Ordinances pertaining to those fees; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WHITE SETTLEMENT, TEXAS THAT:

SECTION I.

There is hereby adopted an amended Chapter 22, Sections 22.6 and 22.7 of the Code of Ordinances of the City of White Settlement as follows:

SECTION II

This Ordinance shall be cumulative of all provisions of ordinances and of the Code of the City of White Settlement, Texas, as amended, except where the provisions of this ordinance are in direct conflict with the provisions of such other ordinances and such Code, in which event the conflicting provisions of such ordinances and such Code are hereby repealed.

SECTION III

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this Ordinance since the same would have been enacted by the City Council without incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

SECTION IV

All rights and remedies of the City of White Settlement, Texas, are expressly saved as to any and all violations of the provisions of the White Settlement Municipal Code or any other ordinances affecting the issuance of permits and the payment of fees which have accrued at the time of the effective date of this Ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances same shall not be affected by this Ordinance but may be prosecuted until final disposition by the courts.


SECTION V

The City Secretary of the City of White Settlement is hereby directed to publish in the official newspaper of the City of White Settlement, the caption, publication clause and effective date clause of this Ordinance as required by Section 19 of the Charter of the City of White Settlement.

SECTION VI

This Ordinance shall be in full force and effect from and after its passage and publication as required by law, and it is so ordained. Effective the 20th day of February, 2014.
