ORDINANCE NO. 2024-020

AN ORDINANCE OF THE CITY OF FRESNO, CALIFORNIA,
AMENDING SUBSECTION (B) OF SECTION 4-107 OF THE
FRESNO MUNICIPAL CODE RELATING TO CONTRACTS
NOT REQUIRING COMPETITIVE BIDDING

THE COUNCIL OF THE CITY OF FRESNO DOES ORDAIN AS FOLLOWS:

SECTION 1. Subsection (b) of Section 4-107 of the Fresno Municipal Code is amended
as follows:

(b) Except for contracts for legal services, the City Manager is authorized to enter into contracts for which an appropriation has been made or is unnecessary; provided the contract involves an expenditure of city moneys, receipts of funds from another party, or liability exposure of less than or equal to one hundred thousand dollars \$100,000 ~~fifty thousand dollars (\$50,000)~~. Council approval of any contract or any amendment to the contract for services under this subsection is required if the total proposed expenditure of city moneys under the contract and any amendments thereto exceeds the respective amount for which the City Manager is authorized to contract.

SECTION 2. This ordinance shall become effective and in full force and effect at 12:01 a.m. on the thirty-first day after its final passage.
