**ORDINANCE NUMBER 23-033**

**AN ORDINANCE OF THE VILLAGE OF LANSING AMENDING SECTION 2-138 (“MEETINGS-REGULAR”) OF ARTICLE VI (“BOARD OF TRUSTEES”) OF CHAPTER 2 (“ADMINISTRATION”) OF THE LANSING MUNICIPAL CODE RELATED THE TIME OF THE REGULAR MEETINGS OF THE BOARD OF TRUSTEES**

**WHEREAS**, the Village of Lansing, Cook County, Illinois (the “*Village*”) is a home rule municipality pursuant to Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, and as such may exercise any power and perform any function pertaining to its government and affairs (the “*Home Rule Powers*”); and

**WHEREAS**, the Village President and Board of Trustees of the Village (the “*Corporate Authorities*”) may from time to time amend the text of the Lansing Municipal Code (the “*Code*”) when it is determined to be in the best interests of the residents of the Village; and

**WHEREAS**, the Corporate Authorities desire to change the time of the regular meetings of the Board of Trustees to 6:00 p.m.; and

**WHEREAS**, the Corporate Authorities have determined that the following changes to its Village Code are in the best interest of the Village in order to protect the health, safety and welfare of its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Village President and Board of Trustees of the Village of Lansing, Cook County, Illinois, by and through their Home Rule Powers, as follows:

**Section 1:** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2:** Section 2-138 (“*Meetings-Regular*”) of Article VI (“*Board of Trustees*”) of

Chapter 2 (“*Administration*”) of the Lansing Code is hereby amended by deleting the stricken language and adding the underlined language to read, as follows:

**Sec. 2-138. – Meetings-Regular**

- (a) The regular meetings of the board shall be held on the first and third Tuesday of each calendar month, at ~~7:00~~ 6:00 p.m., at the Lansing Municipal Court Complex at 2710 170th Street, Lansing, Illinois. There shall be no meeting on the first Tuesday during the months of January, July and August, unless otherwise called by the village president or board of trustees.

**Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 5.** The Village Clerk is hereby authorized and directed to publish this Ordinance in pamphlet form and this Ordinance shall be in full force and effect immediately after its adoption, approval and publication to ensure the public health, safety and welfare of the residents of the Village.
