ORDINANCE # 621-2021

AN ORDINANCE AMENDING THE CITY OF CONVERSE CODE OF ORDINANCE CHAPTER 36. SOLID WASTE BY ADDING SECTIONS 36-1 THROUGH 36-7 TO ARTICLE I. IN GENERAL, AND BY ADDING ARTICLE II. RATES AND FEES, SECTION 36-8 RESIDENTIAL RATES; SUPERCEDING ORDINANCES REGULATING THE ABOVE ISSUES, AND REPEALING ORDINANCE NO. 621-2019, SOLID WASTE RATES FOR RESIDENTIAL CUSTOMERS.

WHEREAS, Chapter 36 of the Code of Ordinances provides for the regulatory authority of the City's Municipal Solid Waste Program; and

WHEREAS, to clearly identify the general requirements of solid waste collection amending Chapter 36 by adding Article I. In General, to identify Sections 36-1 through 36-7 is desired.

WHEREAS, the City's Municipal Solid Waste Collection and Transport Agreement with Waste Management authorizes an increase based on the Consumer Price Index for US City Average for all Urban Consumers, Garbage and Trash Collection, not seasonally adjusted (C.P.I.); and

WHEREAS, the C.P.I. for 2021 increased by 3.7%; and

THUS, Waste Management has increased the City's Solid Waste Base Rate by 3.7%; and

WHEREAS, the City desires to pass on this increase to the residential customers.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Converse, Texas, that Chapter 36, Solid Waste, of the Code of Ordinances of the City of Converse, Texas, is hereby amended as follows:

SECTION 1. By adding an article to Chapter 36 to be titled: **ARTICLE I. IN GENERAL**, and categorizing Sections 36-1 through 36-7 of the Code of Ordinances under this Article.

SECTION 2. By adding an article to Chapter 36 to be titled: **ARTICLE II. RATES AND FEES**, and adding Section 36-8 Residential Rates to read as follows:

Section 36-8. - Residential Rates.

Residential solid waste rate: Customers will be charged \$23.59 per month for each single-family unit.

SECTION 3. This Ordinance supersedes all previous versions in conflict with the ordinance relating to Chapter 36 Solid Waste Rates for Residential Customers.
