

## ORDINANCE 2023-1

AN ORDINANCE ESTABLISHING THE REGULAR MEETING OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF ADDIS PURSUANT TO LOUISIANA REVISED STATUTE 33:405(2). THIS ORDINANCE REVISES AND AMENDS ADDIS CODE OF ORDINANCES, ARTICLE II, SECTION 2-21 “*REGULAR MEETINGS*” TO PROVIDE THAT THE REGULAR MEETING AS REQUIRED BY STATUTE SHALL BE THE SECOND TUESDAY OF EACH MONTH COMMENCING AT THE ADDIS TOWN HALL AT 6:00 PM. THIS ORDINANCE SHALL BE EFFECTIVE COMMENCING WITH THE MEETING OF MARCH 14, 2023 AND CONTINUING EACH MONTH ON THE SECOND TUESDAY THEREAFTER.

WHEREAS, the Mayor and Town Council of the Town of Addis are empowered and required to set and hold a regular monthly meeting each month on a date, time and location set by Ordinance pursuant to LSA-R.S. 33:405(2); and

WHEREAS, the Town Council for the Town of Addis is desirous of revising and amending the Addis Code of Ordinances, Article II, Section 2-21 “Regular Meetings” to provide that the regular meeting as required by statute shall be the second Tuesday of each month commencing at the Addis Town Hall at 6:00 PM.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and the Town Council of the Town of Addis, Louisiana acting as the governing authority thereof, that they do hereby revise and amend Addis Code of Ordinances, Article II, Section 2-21 “Regular Meetings” to read as follows:

**“Sec. 2-21. - Regular meetings.**

The regular meeting of the Mayor and Town Council shall be at 6:00 p.m. on the second Tuesday of each month at the town hall.”

**BE IT FURTHER ORDAINED** by the Town Council of the Town of Addis, Louisiana that any provisions or items of this Ordinance or the application thereof if held invalid, such invalidity shall not affect other provisions, items, or applications, and to this end, the provisions of this Ordinance are hereby declared severable.

**BE IT FURTHER ORDAINED** by the Town Council of the Town of Addis, Louisiana that the effective date of this Ordinance shall be March 1, 2023, with the first regular meeting occurring on March 14, 2023 at 6:00 PM at the Addis Town Hall.

**BE IT FURTHER ORDAINED**, by the Mayor and the Town Council of the

Town of Addis, Louisiana, acting as the governing authority thereof, that this Ordinance shall be designated as Ordinance 2023-1.

THIS ORDINANCE HAVING BEEN INTRODUCED at a Regular Meeting of the Mayor and Town Council on the 4<sup>th</sup> day of January, 2022, and having been read paragraph by paragraph at a Regular Meeting of the Mayor and Town Council of the Town of Addis, Louisiana, duly convened on the 1<sup>st</sup> day of February, 2023, said Ordinance was,
