

ORDINANCE NO. 1646

AN ORDINANCE ADDING A NEW SECTION TO ARTICLE 20 SUPPLEMENTAL DISTRICT REGULATIONS OF THE ZONING REGULATIONS OF THE CODE OF THE CITY OF OSAGE CITY, KANSAS AND AMENDING ARTICLE 9 COMMERCIAL ZONED DISTRICTS, ARTICLE 15 INDUSTRIAL DISTRICTS, ARTICLE 20 SUPPLEMENTAL DISTRICT REGULATIONS, AND ARTICLE 2 RULES, INTERPRETATIONS AND DEFINITIONS OF THE ZONING REGULATIONS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OSAGE CITY, KANSAS:

SECTION 1: A new section to Article 20 Supplemental District Regulations of the Zoning Regulation of the Code of Ordinances of City of Osage City, Kansas is hereby added to read as follows:

SECTION 20-13 KENNELS and Section 20-1301 Prohibition of Kennels. There shall not be permitted in any zoned district the establishment of a kennel as that term is defined in these regulations.

SECTION 2: Violation of this section shall constitute a violation of the City Code and subject to the penalties thereof.

SECTION 3: Section 9-3 Permitted and Conditional uses, Table 9-1, of Article 9 Commercial Zoned Districts of the Zoning Regulations for the City of Osage City, Kansas, is hereby amended by deleting listed use number 26, Kennels Boarding and breeding as a permitted use.

SECTION 4: Section 15-2 Permitted and Conditional Uses, Table 15-1, of Article 15 Industrial Districts of the

Zoning Regulations for the City of Osage City, Kansas, is hereby amended by deleting "and kennels" as a permitted use on Line 3.

**SECTION 5:** Section 20-1204.b. Animal care other than grooming, of Article 20 Supplemental District Regulations of the Zoning Regulations for the City of Osage City, Kansas, is hereby amended to "Kennels and animal care other than grooming".

**SECTION 6:** Section 2-3 Definitions Kennel, of Article 2 Rules, Interpretations and Definitions is hereby amended to read as follows:

Kennel. Means any establishment, commercial or otherwise, maintained for breeding, rearing, grooming, boarding, or otherwise harboring in an enclosure in one location only, more than five dogs or five cats or a total of more than eight dogs and cats six months of age or more.

**SECTION 7:** This ordinance shall be published once each week for two consecutive weeks in the official city newspaper.
