ordinance no. 79

AN ORDINANCE providing for the annexation to the Town of College Place, Washington, of certain territory contiguous to said town.

BE IT ORDAINED by the Council of the Town of College Place, Washington:

Section 1. A written Petition having been filed with the Town Council of College Place, Washington, on the // day of // day of 1951, and signed by the owners of more than seventy-five per cent (75%) in value, according to the assessed value for general taxation of the property described in said Petition; after due notice and hearing and taking of proof, as required by law and the Ordinances of the Town of College Place, it appears that said territory hereinafter described is within the County of Walla Walla, and contiguous to the Town of College Place, Washington; it further appearing that said Petition was signed by owners of more than seventy-five per cent (75%) in value, according to the assessed value for general taxation of the property described in said Petition, and it further appearing that all requirements have been met by said petitioners and the owners of said property that are prerequisite to said territory being annexed to the Town of College Place, and it further appearing that it is for the best interests of the Town that all of the territory described in said Petition should be annexed and become a part of the Town of College Place, effective immediately upon the passage of this Ordinance.

Section 2. From and after the effective date of this Ordinance, the following described real property and territory situated in the County of Walla Walla, State of Washington, to-wit:

Beginning at a point which is 60 feet East of the Northwest corner of the Southwest quarter of the Southwest quarter of Section 25 in Township 7 North, of Range 35 East of the Willamette Meridian, and running thence South, parallel to the West line of said Southwest quarter of Southwest quarter, a distance of 988 feet; thence North 79° 00' East to the East line of Valley Marketing Center, according to the official plat thereof of record in the office of the Auditor of Walla Walla County, Washington; thence North along the East line of said Valley Marketing Center to the North line of said Valley Marketing Center; thence Southwesterly along the Northerly line of said Valley Marketing Center to the point of intersection of said Northerly line with a line drawn parallel to and 180 feet East of the West line of the Southwest quarter of the Southwest quarter of Section 25 aforesaid; thence North along said parallel line to the North line of N.E. "C" Street (formerly Gravenstein Avenue); thence West along the North line of said N.E. "C" Street. a distance of 120 feet; thence South 40 feet to the point of beginning.
