ORDINANCE NO. 376

AN ORDINANCE authorizing certain emergency appropriations for the "Ambulance Fund" for the year of 1971 and providing funds for said appropriation and for the payment thereof, and declaring an emergency.

BE IT ORDAINED by the Town Council of the Town of College Place, Washington:

Section 1. That since the budget was adopted for the year of 1971 for the Town of College Place, it was found that there was a dispute between the Town of College Place and the City of Walla Walla, Washington, relative to the obligation of the Town of College Place to make payment to the City of Walla Walla for ambulance service theretofore provided by the City of Walla Walla for the residents of the Town of College Place and the area within the corporate limits of said Town of College Place. That said disagreement was compromised and settled on the basis of the Town of College Place agreeing to pay a compromise sum in the amount of \$5,451.00, with one-half of said sum to be paid during the year of 1971 and the remaining one-half to be paid in the year of 1972.

Section 2. That the requirement to pay the compromise funds in the sum of \$2,785.50 to the City of Walla Walla during the year of 1971 could not have been anticipated at the time of the preparation of the 1971 Budget. That said expenditure is necessary and the services were made available to the Town of College Place and its residents and such sum should be authorized and appropriated for the "Ambulance Fund" of said Town. That there are sufficient funds in the "Current Expense Fund" of said Town which can be transferred and appropriated to the "Ambulance Fund".

Section 3. That since the adoption of the 1971 Budget for the Town of College Place, it has been found that it will be necessary to pay salaries for drivers and operators of the ambulance being operated by the Town of College Place. That such salaries will exceed \$500.00. That such expenditure could not reasonably have been anticipated at the time of the preparation of the 1971 Budget.

Section 4. That it is necessary to appropriate the total sum of \$3,500.00 for the "Ambulance Fund" of the Town of College Place for the year of 1971; said sum to be used for the purpose of making payment of the sum of \$2,785.50 to the City of Walla Walla and the balance for the salaries of ambulance attendants and drivers. That said sum should be transferred from the "Current Expense Fund" of said Town.

Section 5. That an emergency exists at this time in that moneys are required in the "Ambulance Fund" of said Town for the purpose of paying prior ambulance service furnished by the City of Walla Walla to said Town and the residents thereof, and to provide attendants and drivers for the present ambulance service. That an emergency exists and this Ordinance shall become effective immediately upon its passage and posting as required by law.
