AN ORDINANCE providing for the annexation to the City of College Place of certain territory contiguous to said City; Certifying to compliance with Ordinance No. 62; and providing for the effective date of this Ordinance.

BE IT ORDAINED BY the Council of the City of College Place, Washington:

<u>SECTION 1</u>: A written petition having been filed with the City Council of College Place, Washington on November 13, 1979, signed by the owners of more than 75% in value according to the assessed value for general taxation, of the property described in said petition; after notice and hearing and the taking of proof as required by law, it appears that said territory hereinafter described is within the County of Walla Walla and contiguous to the City of College Place, Washington, and that it is for the best interests of the City that all of the territory described in said petition should be annexed and become a part of the City of College Place effective immediately upon the passage of this Ordinance.

<u>SECTION 2</u>: That from the report of the Engineer for the City of College Place, the Superintendent of the Water Department of Public Works, it would appear that all water lines, fire hydrants and street improvements necessary to comply with the requirements of Ordinance No. 62 of the City of College Place have all been installed and are in satisfactory condition to comply with said Ordinance No. 62, and by reason thereof there is no necessity for additional work relating to said facilities to be done or any necessity for any bond relating thereto.

<u>SECTION 3</u>: From and after the effective date of this Ordinance the following described real property situated in the County of Walla Walla, State of Washington, to-wit:

Beginning at a point 20 feet south and 38 feet west of the monument at the intersection of the center line of S.E. Eighth Street with the north and south center line of Section 36 in Township 7 North, Range 35 East of the Willamette Meridian; and running thence south, along the east line of Block 9 of College Place No. 2, according to the official plat thereof of record in the office of the Auditor of Walla Walla County, Washington, in Volume "B" of plats at page 59, a distance of 226.3 feet; thence north 87° 27' west 135.7 feet; thence north 2° 00' west 219.35 feet to the south line of said S.E. Eighth Street; thence north 89° 38' east, along said south line, a distance of 143.0 feet more or less to the point of beginning.

shall be, and is hereby annexed to and become a part of the incorporated limit of the City of College Place.

<u>SECTION 4:</u> The proper hearing has been had pertaining to fixing the liability if any, of the area herein before described to pay for prior obligations of the City of College Place. That pursuant to said hearing and the conclusions reached therein, it is ordered and directed that the tract of land hereinbefore described and annexed to the City of College Place shall not be required to pay any prior indebtedness of the City of College Place.

SECTION 5: This Ordinance shall be of full force and effect immediately upon its adoption and posting as required by law.
