AN ORDINANCE ASSIGNING NEW DUTIES TO THE CITY AUDITOR, TO-WIT: PERFORMANCE AUDIT, GOVERNANCE AUDIT, RISK MANAGEMENT AUDIT, AND INTERNAL CONTROLS AUDIT; REQUIRING THE CITY AUDITOR TO PERFORM SAID AUDITS PERIODICALLY; REQUIRING THAT THE CITY AUDITOR REPORT THE RESULTS OF SAID AUDITS TO THE MAYOR AND CITY COUNCIL; PROVIDING FOR SEVERABILITY; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND DECLARING AN EMERGENCY.

WHEREAS, Article IV of the Tulsa City Charter establishes the office of the City Auditor; and

WHEREAS, Section 3 of said Article IV sets forth the duties of the City Auditor; and

WHEREAS, Sub-section G of said Section 3 provides that the City Auditor shall perform other duties as the Council shall assign by ordinance; and

WHEREAS, the ordinances pertinent to the City Auditor are found at Title 4, Tulsa Revised Ordinances, Chapter 2;

BE IT ORDAINED BY THE CITY OF TULSA:

*Section 1. That Title 4 Tulsa Revised Ordinances, Chapter 2 is hereby amended, by the addition of a new section, Section 207, which shall read as follows.*

**"Section 207. Additional duties.**


The City Auditor shall examine periodically the City of Tulsa's performance, governance processes, risk management processes and systems of internal controls, and report in writing the results of such examinations to the Mayor and the City Council."

*Section 2. SEVERABILITY CLAUSE: If any section, sentence, clause or phrase of this ordinance or any part thereof is for any reason found to be invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remainder of this ordinance or any part thereof.*

*Section 3. REPEAL OF CONFLICTING ORDINANCES. That all ordinances or parts of ordinances in conflict herewith be and the same are now expressly repealed.*

*Section 4. EMERGENCY CLAUSE. That the amendments hereby enacted are essential to the proper, orderly and ethical conduct of the business of the City of Tulsa by its City*

*Officials; therefore, an emergency is hereby declared to exist for the preservation of the public peace, health, and safety, by reason whereof this ordinance shall take effect immediately upon its passage, approval, and publication.*

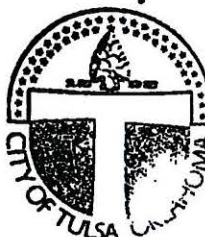


