RESOLUTION OF THE CITY OF WEST MIAMI ADOPTING AND IMPLEMENTING THE RESULTS OF THE NOVEMBER 5, 2024 ELECTION APPROVING CERTAIN AMENDMENTS TO THE CHARTER OF THE CITY OF WEST MIAMI; DIRECTING THE CITY CLERK TO FILE SAID CHARTER AND ITS AMENDMENTS WITH THE CLERK OF MIAMI-DADE COUNTY AND FURTHER INSTRUCTING THE CITY CLERK TO FORWARD THE CITY CHARTER WITH ITS AMENDMENTS TO THE MUNICIPAL CODE CORPORATION (MUNICODE) FOR ITS PUBLICATION.

WHEREAS, the City of West Miami Commission appointed a Charter Review Board to review the City Charter and recommend to the City Commission certain proposed amendments to be offered to the voters of the City of West Miami for their consideration in the November 5, 2024 election; and

WHEREAS, the Charter Review Board recommended to the City Commission a total of two (2) charter amendments; and

WHEREAS, a total of two (2) Charter amendments were offered to the voters of the City of West Miami in the November 5, 2024 election; and

WHEREAS, the Charter amendments as attached herein and made a part hereof as Exhibit A, were voted upon by the citizens of the City of West Miami; and

WHEREAS, the Miami Dade County Elections Department canvassed the election return, tabulated ballots and determined the number of votes in each proposed charter amendment as attached herein as Exhibit A; and

WHEREAS, Both two(2) proposed Charter amendments were approved by the voters of the City of West Miami.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Commission of the City of West Miami that:

- **SECTION 1.** The aforementioned statements are true and correct and adopted as is fully stated herein.
- **SECTION 2.** The City Commission hereby accepts and adopts the certification by the Miami-Dade County Elections Department whereby the attached amendments were approved.
- **SECTION 3.** Said amendments are hereby accepted as approved by the Miami-Dade County Elections Department.

SECTION 4. The City Clerk is hereby instructed to remit and file this Resolution and the adopted Charter Amendments with the Clerk of the Miami-Dade County.

SECTION 5. The City Clerk is hereby instructed to remit the City of West Miami Amended Charter to the Municipal Code Corporation (Municode) for its publication.

SECTION 6. The City Clerk is hereby authorized and directed to perform any and all incidental duties in connection herewith as required by law.
