ORDINANCE NO. 4731

**AMENDING SECTION 66-31 AND SECTION 66-51 IN CHAPTER 66 OF THE
MICHIGAN CITY MUNICIPAL CODE TO CHANGE THE NAME OF THE HUMAN
RIGHTS DIRECTOR TO THE ASSISTANT HUMAN RESOURCE DIRECTOR**

WHEREAS, currently there is only one (1) Human Resource (HR) Director for the entire City, and the need for additional help in this Department currently exists; and

WHEREAS, for efficiency purposes, the Mayor reasonably believes that the Human Right's Director position should be restructured, and more specifically said position can continue to perform the duties and responsibilities associated with the Human Rights Department but can also easily absorb additional HR responsibilities to assistant the HR Director; and

WHEREAS, the Mayor reasonably believes that due to the restructuring of the aforementioned position, the Human Rights Director should now be known as the Assistant Human Resource (HR) Director; and

WHEREAS, the Common Council desires to implement the Mayor's suggested restructuring and believes said changes are reasonable and in the best interest of the City; and

WHEREAS, the need now exists to amend various sections in Chapter 66 of the Michigan City Municipal Code to reflect that the Human Rights Director shall now be known as the Assistant Human Resource Director.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MICHIGAN CITY, INDIANA that the following sections of the Michigan City Municipal Code shall be amended as follows:

1. The definition of "Director" in Sec. 66-31 is hereby amended to now read as follows:

Director means the Assistant Human Resource Director.

2. Sec. 66-51 is hereby amended to now read as follows:

Sec. 66-51. Human Rights Department.

There is hereby established a Department of Human Rights. The Department shall be headed by the Assistant Human Resource Director.

This Ordinance shall be effective upon passage and approval by the Mayor.
