NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF TOPSAIL BEACH, NORTH CAROLINA, THAT:

The Code of Ordinances, CHAPTER 28 – SOLID WASTE MANAGEMENT, ARTICLE II. COLLECTION AND REMOVAL and CHAPTER 1 – GENERAL PROVISIONS, SECTION 1-7 – TABLE OF CHARGES FOR CIVIL VIOLATIONS OF CODE is hereby amended to read as:

#### ARTICLE II. COLLECTION AND REMOVAL

# Sec. 28-33. Recycle Center

The Town's Recycle Center is for use by Topsail Beach Property Owners, Topsail Beach Residents, Topsail Beach Renters, and Topsail Beach Businesses ONLY.

## Sec. 28-34. Accepted Items

Accepted Items as approved by the Regional Recycle Facility. The official list will be on file in the Clerk's Office at Town Hall. A copy will also be available on the Town website at www.topsailbeachnc.gov.

#### Sec. 28-35. Prohibited Items

The following items shall not be deposited at the Recycling Center: Styrofoam, plastic bags, window glass and mirrors, electronic waste, motor oil containers, paint cans, chemical containers, lightbulbs, yard waste, shredded paper, ceramics or dishes, food waste, and scrap metal.

# Sec. 28-36. Violations and Civil Charges

Any person violating any provision of this Article is subject to administrative imposition of a civil charge per sections 1-6(f) and 1-7. – Table of charges for civil violations of Code.
