ORDINANCE NO. 24-07

**AN ORDINANCE TO AMEND CHAPTER 46, “ZONING” OF THE CODE
OF ORDINANCES OF THE CITY OF GREENVILLE BY AMENDING
SECTION 46-83 PERTAINING TO SWIMMING POOLS.**

Councilmember Lehman, supported by Councilmember Cunliffe, moved the adoption of the following ordinance:

THE CITY OF GREENVILLE ORDAINS:

Section 1. Amendment of Section 46-83. Section 46-83 of Chapter 46, “Zoning” of the Code of Ordinances of the City of Greenville is amended to read as follows:

Sec. 46-83. - Swimming pools.

- (a) Any swimming pool, spa, hot tub and other similar apparatus, which is below ground or above ground and which is either portable or permanent, which has a capacity in excess of 50 gallons and is capable of holding a depth of two feet or more of water at any one point, shall comply with the requirements of article II of chapter 8, Fencing of such swimming pools and similar apparatus shall comply with the requirements of section 46-82.
- (b) Pools shall not be closer than six feet to any side or rear lot line. Pools shall not be located within a front yard and shall not be closer than six feet to any building.

Section 2. Publication and Effective Date. This Ordinance shall be published in the *Daily News*, a newspaper of general circulation in the City within 10 days of its adoption, and shall be effective 15 days after its adoption provided it has been published.
