#### ORDINANCE NO. 481

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ATLANTIS, FLORIDA, AMENDING CHAPTER 15. ZONING. AT ARTICLE I. IN GENERAL. SEC. 15-5 DISTRICT REGULATIONS. PARAGRAPH (f) DISTRICT – R1 SINGLE FAMILY RESIDENTIAL, TO AMEND CERTAIN AESTHETIC AND DESIGN STANDARD REQUIREMENTS FOR ROOF MATERIAL OR PAINT COLOR AT FIVE VILLA GROUPS LOCATED IN THIS ZONING DISTRICT WHICH ARE CONSISTENT WITH THE RESPECTIVE FIVE VILLA GROUP REGULATIONS FOR ROOF MATERIAL AND PAINT COLOR AS APPLICABLE; PROVIDING THAT EACH AND EVERY OTHER SECTION AND SUBSECTION OF CHAPTER 15. ZONING. SHALL REMAIN IN FULL FORCE AND EFFECT AS PREVIOUSLY ADOPTED; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE, AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City Council adopted Ordinance 460 in 2021 as part of a city-wide comprehensive code update, and codified architectural design guidelines for the various villa groups located in this zoning district; and

WHEREAS, since the adoption of Ordinance 460, five of the individual villa groups have had to amend their architectural design guidelines due to circumstances beyond their control, such as the unavailability of materials or the discontinuation of supplies, and

WHEREAS, consistent, objective review and approval of development applications from properties within the City's villa groups by the City's Architectural Review Committee is not possible without consistency between Villa Group standards and City code; and

WHEREAS, the City Council now desires to update the City's code consistent with changes to villa group design guidelines.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTIS, FLORIDA, AS FOLLOWS:

<u>Section 1:</u> The foregoing recitals are true and correct, and are hereby made a specific part of this Ordinance.

Section 2: Chapter 15. Zoning. of the Code of Ordinances of the City of Atlantis, Florida, is hereby amended at Article I. In General. Sec. 15-5(f)(7), to revise roof material

standards consistent with revisions at four villa groups, and paint color standards consistent with revisions at one villa group as follows:

- (7) Villa group architectural aesthetics and design elements.
  - a. Applicability and purpose. All properties located within a villa group shall comply with architectural and design elements respective to each villa group in order to provide for consistency in aesthetics, development review, and redevelopment within all City villa group neighborhoods.
  - b. Permitted Villa Group architectural and design elements. All architectural and design elements within a villa group are to be color, material, and style compatible with the overall villa group aesthetics. Architectural and design elements are not limited to the specific core elements listed below. Manufacturer equivalencies are acceptable.

c. Action by Architectural Committee and City Council. The City of Atlantis Architectural Committee as provided for in sec. 15-10 shall review all applicable aesthetic applications for a building permit and architectural approval (in the case of painting a building or structure) in accordance with the permitted elements listed above and in addition to provisions in sec. 15-10. The Architectural Committee shall function as a recommendation body to the City Council for any interpretations that may arise or requested deviations, in which case the City Council shall be the final decision-making authority.

**SECTION 3:** Each and every other section and subsection Chapter 15. Zoning. of the Code of Ordinances of the City of Atlantis, Florida, shall remain in full force and effect as previously adopted.

**SECTION 4**: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION 5:** Should any section or provision of this Ordinance, or any portion thereof, be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remainder of this Ordinance.

**SECTION 6**: Specific authority is hereby granted to codify this Ordinance.

**SECTION 7:** This Ordinance shall take effect immediately upon adoption.
