SECTION 1.

Subdivision 2 of Section 158.11 of the Laws of Westchester County is hereby amended to read as follows:

The County Attorney shall be legal advisor to the County Board and to each and every board, body, commission or officer of the County of Westchester and to each and every employee of the County of Westchester as may be required by section 297.31 of the Westchester County Administrative Code. It shall be the County Attorney's duty to furnish to such county board, body, commission, officer, or employee all such advice and legal assistance as counsel and attorney in and out of court as may be required by them, or either of them. No such officer, employee, board, body, commission, or department of the county shall have or employ any attorney or counsel unless specifically authorized to do so by the County Board.

SECTION 2. Effective date.

This Local Law shall take effect immediately.
