

## EMERGENCY RESOLUTION NO. 16-2022

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A SERVICE AGREEMENT BY AND BETWEEN THE CITY OF MONROE AND AXON ENTERPRISE, INC. FOR THE SERVICE AND LICENSING OF THE DEPARTMENT OF POLICE BODY CAMERA AND DECLARING AN EMERGENCY.

WHEREAS, the existing service and licensing agreement for the body cameras used by the Department of Police expires in April of 2022; and

WHEREAS, Council deems it necessary to enter into a five-year agreement for the service and licensing of said body cameras to avoid any downtime in the equipment and software.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MONROE, STATE OF OHIO, THAT:

SECTION 1: The City Manager is hereby authorized to enter into a service agreement by and between the City of Monroe and Axon Enterprise, Inc. for the service and licensing of the Department of Police body cameras pursuant to the terms and conditions set forth on Exhibit "A" attached hereto and made a part hereof.

SECTION 2: This measure is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare and further for the reason that Council desires to avoid any downtime in the equipment and software. Therefore, this measure shall take effect and be in full force from and after its passage.
