## AN ORDINANCE OF COUNCIL AMENDING, MODIFYING AND RE-ENACTING ARTICLE 361 OF THE CODIFIED ORDINANCES OF THE CITY OF HUNTINGTON, AS REVISED, REGARDING PARKING GENERALLY.

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF HUNTINGTON,

**CABELL AND WAYNE COUNTIES, WEST VIRGINIA,** that Article 361 of the Codified Ordinances of the City of Huntington, as revised, is hereby **AMENDED, MODIFIED AND RE-ENACTED** to read as follows:

## ARTICLE 361

## PARKING GENERALLY

361.28 RESTRICTED PARKING NEAR CITY HALL AND COURTHOUSE.

(a) When signs are erected giving thereof, the The following special parking restrictions shall apply on streets adjacent to City Hall and the Cabell County Courthouse:

(1) Only City or County vehicles shall be parked in the designated, non-metered fourteen designated parking spaces on the west side of Eighth Street between Fourth and Fifth Avenues.

(2) Only City vehicles shall be parked in the designated, non-metered parking spaces on the east side of Eighth Street immediately north of the intersection of Eighth Street and Fifth Avenue 4 ½ Alley to the intersection of Eighth Street with Court Street Fourth Avenue.

(3) The first and seventh parking spaces on the east side of Eighth Street immediately north of the intersection of Eighth Street and Fifth Avenue to the intersection of Eighth Street with 4 <sup>1</sup>/<sub>2</sub> Alley is hereby designated for parking by handicapped persons only, when the handicapped person's vehicle is properly identified by a lawful identification plate or sticker. The remaining five spaces between the two handicap spaces shall be reserved for City vehicles only.

(3)(4) Only City County vehicles shall be parked in the designated, non-metered parking spaces on the east and west sides of Seventh Street between the intersections of Fourth and Fifth Avenues with Seventh Street.

(4)(5) Beginning with the first designated parking space on the north side of Fifth Avenue in front of City Hall and continuing eastward along Fifth Avenue for eight parking spaces, said eight spaces shall be reserved and identified for the use of residents and other persons having business with City Hall. Of these eight spaces,

A. The first designated parking space is hereby designated for parking by handicapped persons only, when the handicapped person's vehicle is properly identified by a

lawful identification plate or sticker and shall provide for thirty minutes of free parking;

B. The second through seventh designated parking spaces shall provide for thirty minutes of free parking; and

C. The eighth designated parking spaces shall be designated as "express" parking and provide for five minutes of free parking.

The first designated parking space on the north side of Fifth Avenue in front of City Hall immediately east of Eighth Street is hereby designated for parking by handicapped persons only, when the handicapped person's vehicle is properly identified by a lawful identification plate or sticker.

(5) Beginning with the second designated parking place on the north side of Fifth Avenue in front of City Hall and continuing eastward to a private alley situated on the east side of City Hall and being a total of eight parking spaces, the eight spaces so designated immediately west of such private alley shall be reserved and identified for the use of residents and other persons having business with City Hall, and shall provide for fifteen minutes for free parking. (6) Beginning immediately east of City Hall and continuing eastward along Fifth Avenue are three parking lots. In the space between the curb cuts for the second and third parking lot is one parallel parking space which of such private alley east of City Hall the next five designated parking spaces on the north side of Fifth Avenue in front of what is commonly known as the City Hall Annex shall be reserved and designated for parking for City vehicles only.

(7) The first parking lot to the east of City Hall shall be for parking of such City vehicles as designated by the Mayor with the exception of the first five spaces on the east side of the lot moving north from Fifth Avenue which are reserved for City Council Members and the sixth space which is reserved for the City Clerk. Parking in the lot between the City Hall and the City Hall Annex shall be limited to the following:

A. West side of lot moving North from Fifth Avenue:

1st space: Mayor

2nd space: Administrative Manager

3rd space: Director of Administration and Finance

4th space: Finance Director

5th space: City Attorney

6th space: Director of Department of Development

7th space: Sanitary Board Director

8th space: Planning Director

9th space: Human Relations Commission Director

10th space: Traffic Engineer

11th space: Public Works Director

B. East of lot moving north from Fifth Avenue: 1st through 5th spaces: City Council Members

6th space: City Clerk

C. East side of lot moving south Four and one-half alley: 1st and 2nd spaces: Communications Center

D. All other spaces shall be reserved for authorized vehicles only.

(8) To the north of City Hall beginning at the intersection of Eighth Street and 4 ½ Alley and continuing eastward along the north side of 4 ½ Alley for four parking spaces to a private alley, said spaces shall be reserved for permitted City vehicles. Immediately east of said private alley shall be one parking space hereby designated for parking by handicapped persons only, when the handicapped person's vehicle is properly identified by a lawful identification plate or sticker.

(b) As used in this section "City vehicle," means City vehicles owned by the City or privately owned vehicles of City officials to whom a parking permit has been issued. As used in this section "County vehicle" means either County-owned vehicles or vehicles owned by County officials to whom a space has been assigned. The Mayor or his designee shall issue permits for use of the reserved spaces referenced in this section. A permit shall be issued to the Mayor and to the members of Council. The Mayor may also issue a parking permit to department heads who are called upon occasionally to use their personal vehicles for City business.

**BE IT FURTHER ORDAINED** that Section 361.28 shall become effective upon its adoption by Council and approval by the Mayor.

**BE IT FURTHER ORDAINED** that all other sections and sub-sections of Article 361 of the Codified Ordinances of the City of Huntington, as revised, shall remain in full force and effect until further Ordinance of this Council.
