

**ORDINANCE NO. 1222**

**ORDINANCE OF THE CITY OF HOLLISTER AMENDING CHAPTER 15.04 OF THE HOLLISTER MUNICIPAL CODE REGARDING THE ADOPTION OF THE 2022 CALIFORNIA BUILDING CODES AND RELATED INTERNATIONAL CODES**

**WHEREAS**, The California Building Standards Commission adopted the 2022 Edition of the California Building Codes in January 2022.; and

**WHEREAS**, the California Health and Safety Code requires local governments to adopt the most recent editions of the California Building Codes; and

**WHEREAS**, local governments must update their building codes by repealing, amending and adopting the State Codes to become effective January 1, 2023.

**NOW THEREFORE, BE IT RESOLVED**, that the City Council of the City of Hollister does hereby ordain as follows:

**THE CITY COUNCIL OF THE CITY OF HOLLISTER DOES ORDAIN AS FOLLOWS:**

**Section 1.** Section 15.04.050 repealed, amended and replaced in its entirety. Section 15.04.050 is hereby replaced in its entirety to read as follows:

15.04.050. "Construction codes adopted by reference."

The following codes, which are on file and available for public inspection at City Hall, are adopted by reference as fully as if set forth verbatim. 2022 Edition of the California Building Standards, Title 24 of the California Code of Regulations, in its entirety consisting of the following parts:

**Section 2.** Severability. The City Council declares that, should any provision, section, paragraph, sentence, or word of this ordinance be rendered or declared invalid by any final court action in a court of competent jurisdiction or by reason of any preemptive legislation, the remaining provisions, sections, paragraphs, sentences, or words of this ordinance as hereby adopted shall remain in full force and effect.

**Section 3.** Effective Date. This ordinance shall take effect thirty (30) days after final passage by the City Council.

**Section 4.** Publication. Within fifteen (15) days after passage, the City Clerk shall cause this ordinance to be published one time in The Free Lance, a newspaper of general circulation.
